8 - The classes, or regional or other groups, of members that the corporation is authorized to establish

There shall be one class of members, consisting of individuals who support the Corporation's purpose and have been accepted into membership by ordinary resolution of the Board. Each member is entitled to receive notice of, attend and vote at all meetings of the members of the Corporation.

9 - Statement regarding the distribution of property remaining on liquidation

In the event of dissolution or winding up of the Corporation, all its remaining assets (after paying liabilities) shall be distributed to one or more qualified donees as defined by the Income Tax Act.

10 - Additional provisions, if any

Directors of the Corporation shall serve without remuneration. No director shall, directly or indirectly, receive profit from the director's position as such. A director may be reimbursed for reasonable expenses incurred in performing the director's duties and may receive compensation for services provided to the Corporation in another capacity.
