

#### FORM 4009 - ARTICLES OF AMALGAMATION

#### The purposes of the Corporation are:

- 1. to educate and train health professionals in the delivery of sexual and reproductive health services;
- 2. to advance education by researching, monitoring, and analyzing sexual and reproductive health standards, practices and policy and disseminating the results of such research to the public in Canada, or elsewhere;
- 3. to advance education by supporting ethical research into the social, legal, medical, and other aspects of sexual and reproductive health and rights and disseminating the results of such research to the public in Canada, or elsewhere;
- 4. to advance education by providing awards and scholarships to post-secondary students studying sexual and reproductive health and rights;
- 5. to educate and increase the public's awareness in Canada, or elsewhere, on issues of sexual and reproductive health and rights; and
- 6. to improve the capacity of other registered charities by providing information, education, expertise and access to materials on issues related to sexual and reproductive health and rights.

#### SCHEDULE 2

#### FORM 4009 - ARTICLES OF AMALGAMATION

- (a) Any By-law, amendment or repeal of a By-law shall require confirmation by Special Resolution of the Members.
- (b) The Corporation shall be carried on without the purpose of gain for its Members, and any profits or other accretions to the Corporation shall be used in furtherance of its purposes.
- (c) Directors shall serve without remuneration, and no Director shall directly or indirectly receive any profit from his or her position as such, provided that a Director may be reimbursed for reasonable expenses incurred in performing his or her duties.
- (d) The Board of Directors may appoint one or more additional Directors who shall hold office for a term expiring not later than the close of the next annual meeting of Members, but the total number of Directors so appointed shall not exceed one-third (1/3) of the number of Directors elected at the previous annual meeting of Members.
