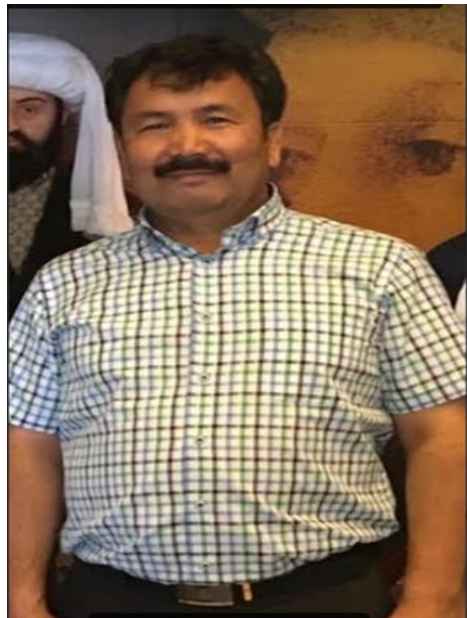

1. **Neghmat Hamit**

Gender: male

He is my elder brother. He was born in 1965, in Ghulja. He came to turkey in 2016 for travelling. He returned back to homeland after visiting 15 days here. His passport was taken back by the state officials, when he arrived to home. He was taken to a concentration camp in Ghulja, 2017, and later transferred to prison and sentenced to 20 years in jail. My brother is a well-known businessman in Ghulja state. He has no crime at all. He was detained and sentenced just because of visiting Turkey where the place is blacklisted in China.



2. **Abdujelil Abdukeyim,**

Gender: male

He was born in 1974, in Ghulja. He is a Well-known businessman. He visited Turkey in 2016 and his passport was taken back by the state officers when he returned to homeland. He was taken to a concentration camp in Ghulja, in 2017. Later, he was also transferred to prison with her wife and both of them were sentenced to 19 years and 10 months in jail. He doesn't have any criminal records which is against the law in China or international. Neither he suspected for any reasons, nor jailed before. He has no crime at all. He was detained and sentenced just because of visiting Turkey where the place is blacklisted in China.



3. **Zibeydem Ezim**

Gender: female

She was born in 1976, in Ghulja. She is a worker in a hospital which is called 'Dosluk Dohturhanisi' in local people's tongue. She is my sister in law. She visited Turkey in 2016 and her passport was taken back by the state officers when she returned to homeland just after visiting us. She was taken to a concentration camp in Ghulja, in 2018. Later, she also transferred to prison with her husband whose name is already mentioned above (Abdujelil Abdukeyim), and both of them were sentenced to 19 years and 10 months in jail together. She doesn't have any criminal records which is against the law in China. Neither she suspected for any reasons, nor jailed history in her entire life. She has no crime at all. She was detained and sentenced just because of visiting Turkey where the place is blacklisted in China.



4. **Dilmurat Dilshat**

Gender: male

He was born in 1982, in Ghulja. He is my cousin. He is a well-known businessman. He visited Turkey in 2016 and his passport was taken back by the state officers when he returned to homeland. He was taken to a concentration camp in Ghulja, in 2018. He is an honest and law-abiding person. He always obeys the law and he is a good citizen too. I am doubt that why Dilmurat was under custody and detention center, and where he is now. Even though, he is innocent and he had no prior criminal record, Chinese government sent him to the so-called 'Re-Education camp'. I have lost contact and I have no information about whether he is sentenced to a jail or alive since he was sent to the concentration camp. He has no crime at all. He was detained and sentenced just because of visiting Turkey where the place is blacklisted in China.
