

Journalist Alex Newman in New American Magazine reported on the sterilization of millions of Kenyan women using a tetanus vaccine. And at a hearing of the Texas state Senate Health and Human Services Committee, [Dr. Peter McCullough, presented facts showing that early treatment could have prevented up to 85% \(425,000\) of COVID-19 deaths](#). Think hydroxychloroquine, zinc, ivermectin, quercetin, etc. Yet early treatments were all heavily furiously censored and suppressed. Is McCullough a quack? He says he is “very pro-vaccine,” and has gotten all the usual vaccines, as well as given them to his kids back in the day. In addition to being a cardiologist and professor of medicine at the Texas A&M University Health Sciences Center, he also has published *the most papers of any person in the history of his field*, and has been editor of two major medical journals, published in Lancet, NEJM, Journal of American Medical Association, lectured at NY Academy of Sciences, the NIH, US Food & Drug Administration, European Medicines Agency and before the US Congressional Oversight Panel. Was also the Vice Chair of Medicine at Baylor Univ., now professor of medicine at Texas A&M, whose focus over the past year has been Covid. Despite that, his video, in which he went through a paper he’d published detailing effective early treatments, was summarily banned by YouTube in 2020. Y’know... those wokester sociology majors at google “know” more. Oh yes. His credentials also include he and his family having had Covid and done well. And how would the vax work? Basically, tThe Covid fake vax has your own body create the famed spike protein. Then, at something called the furin cleavage site, where one’s body would “cleave” it and render it harmless, this now cannot be cleaved thanks to the Wuhan bioengineering funded by Fauci. Dr. Pierre Kory M.D., a pulmonary and critical care specialist and Assistant Professor of Medicine at St. Luke's Aurora Medical Center in Milwaukee, and is the president and chief medical officer of the Frontline COVID-19 Critical Care Alliance (FLCCC). He also tried going to Congress, pleading to have the NIH, CDC, and FDA look at the “mountains” of data that he and his colleagues have gathered on the drug Ivermectin, which is already approved by the FDA as an anti-parasitic drug, and their success in treating COVID patients, stating *“If you take it, you will not get sick.”* Dr. Kory is president of the Frontline COVID-19 Critical Care Alliance (FLCCC), and their success in treating patients with COVID has been so dramatic, that he referred to it as a “miracle drug.” HealthImpactNews.com reviews his testimony [here](#). And speaking of Ivermectin, which is available for horses on Amazon (not that I could recommend you it, thus offending the fake gods at the FDA and CDC, and their bevy of corrupt lawyers) studies show it can help prophylactically once the disease has set in. Ivermectin inhibits replication of SARS-CoV-2, inhibits inflammation through several pathways, lowers viral load, protects against organ damage, prevents transmission of SARS-CoV-2 when taken before or after exposure, speeds recovery and lowers risk of hospitalization and death in COVID-19 patients. Dr. Pierre Kory, as interviewed by Bret Weinstein, discusses this issue at the Bitchute link above, while the Frontline Covid 19 Critical Care Alliance also recommends its use. This COVID-19 protocol was initially dubbed [MATH+](#) (an acronym based components of treatment, FLCC complete description [here](#)), but updated and now called I-MASK+, details [here](#), as they added Ivermectin. The Kory story on Ivermectin is covered by Mercola [here](#). But not to worry! This information is being squashed, as you might suspect. Ivermectin, as outlined in the Kory/Weinstein interview, is simply not allowed to be a go-to remedy. The obvious question is why? Don't they want to save lives? Isn't that why we shut down the world? *“I would have these data arguments,”* Kory says. *“But it's not about the data. There's something else. There's [something] out there that is just squashing, distorting, suppressing the efficacy of ivermectin, and its egregious.”* You gentle reader, need to answer as to *why* this might be being done. 
Incidentally, there's big money to be made in them thar biotech hills! According to a [new report](#) by the People's Vaccine Alliance, at least nine people have now newly joined the billionaire club thanks to the immense profitability of the COVID shot. 

Those who have had Covid before might want to not get the shot, if cardiac surgeon Dr Hooman Noorchashm [has warned and explained on his website](#). It is now known that it is rare to get sick again - Robust natural immunity has been demonstrated for a minimum of eight months after recovery in more than 95% of people (see [Science](#) article here, or [Nature](#) article [here](#)... but that doesn't stop the ninnies at the CDC to recommend you still get the jab. The issue is that are viral antigens that remain in the body after a person is naturally infected; the immune response reactivated by the COVID-19 vaccine may trigger inflammation in tissues where the viral antigens exist, where the inner lining of blood vessels, the lungs and the brain may be particularly at risk of such inflammation, lead to thromboembolic complications – thus one has to wonder if many of those experiencing Covid shot issues had an asymptomatic version of the infection. This may be particularly true of the elderly, who have a cardiac even like Hank Aaron did after the shot, but it was ascribed to his heart. In fact, In France, their la Haute Autorité de Santé (HAS) [does not recommend routinely vaccinating those who have already recovered from COVID-19](#). Cleveland Clinic [research published in June, 2021](#) corroborated that antibodies of those who have had Covid are still active a year later. But – while I am still investigating this – I have had credible reports that the famed Mayo Clinic has scrubbed references to survivors of the 1919 Spanish flu having antibodies that remained a hundred years later. You, dear reader, know why – this could be extrapolated to Covid, and stop the push to give everyone the death jab.

Not that [as of May 21, 2021, almost HALF of Fauci's employees in his Infectious Disease branch of the CDC had NOT, almost a half year after the "vax" was introduced, taken it](#).

Still frantic to get the shot? First, check your blood type if you insist on getting it. [One study found](#) a Covid protein called the receptor binding domain (RBD) — had a strong preference for binding to blood group A found on respiratory cells, while type O may have a lower susceptibility. Dr. Hooman Noorchashm suggests prescreening for SARS-CoV-2 viral proteins to reduce the risk of injuries and deaths following vaccination, as the vaccine may trigger an adverse immune response *in those who have already been infected with the virus* (interview here: <https://youtu.be/h9zvTCYSig>), or as explained on Mercola [here](#). ConsumerLab.com discusses the Pfizer, Moderna and J&J shots [here](#) in terms of efficacy – by their reckoning – and where to get it.

But let's return to the issue of mRNA vaccines not meeting the legal definition of "vaccine." Dr. [Mercola states](#) on this topic: "*referring to them as vaccines, and marketing them as such, is a deceptive practice that violates U.S. Code Section 41 of the Federal Trade Commission Act,10 the law that governs advertising of medical practices. The lack of completed human trials also puts these mRNA products at odds with 15 U.S. Code Section 41. Per this law, it is unlawful to advertise 'that a product or service can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, including, when appropriate, well-controlled human clinical studies, substantiating that the claims are true at the time they are made'.*" Here's the problem: The primary end point in the COVID-19 "vaccine" trials is not an *actual* vaccine trial end point because these end points have to do with immunity and transmission reduction. [Neither of those has been measured](#). What's more, key secondary end points in Moderna's

trial should include prevention of severe COVID-19 disease (defined as need for hospitalization) and prevention of infection by SARS-CoV-2, regardless of symptoms. However, Moderna did not actually measure rate of infection, stating that it was too "impractical" to do so." That means there's no evidence of this gene therapy having an impact on infection, for better or worse. And, if you have no evidence, you cannot fulfill the U.S. Code requirement that states you must have "*competent and reliable scientific evidence ... substantiating that the claims are true.*"

In fact, the legal definition of a vaccine is clear, as evidences by the Iowa government code (see [Rules.iowa.gov ARC 4096C](#)), viz., "*Vaccine means a specially prepared antigen administered to a person for the purpose of providing immunity,*" and the Washington code (see [here](#)), "*Vaccine means a preparation of a killed or attenuated living microorganism, or fraction thereof ...*" The statute also specifies that a vaccine "*upon immunization stimulates immunity that protects us against disease ...*" As we have just seen, none of this applies to the Moderna and Pfizer jabs.

Making matters worse, both Pfizer and Moderna eliminated their control groups by offering the real vaccine to any and all placebo recipients who wanted it. Studies should have gone on for a full two years, but by eliminating the control group, determining effectiveness and risks is near impossible. And as of early March, major problems with the AstraZeneca shot caused Italian officials to seize almost 400k doses of their shot, per [ZeroHedge](#). They joined Iceland, Denmark, Ireland, Spain who have also suspended rollout - a grand total of 18 countries if you count them all!

All this is all to stop a virus that, according to Dr. Jay Bhattacharya, MD This, PhD, Stanford Medical School, per [October's Imprimus that regular, seasonal influenza is two to three times more lethal than Covid for those under age 21](#). Please re-read that again – regular, seasonal influenza is much more lethal to the under 21 crowd than Covid. British biochemist Chris Woolams, founder of the UK's largest cancer charity website concurred with Bhattacharya [March, 2021 on his website](#) in "*India – 1.26% of the 1.388 billion population have caught Covid, 1.36% of those have died. Far less than in a normal year of common 'flu.'*" Yet the utterly ignorant LA public school system, police state-like, now have a Covid tracking app to allow entry to their schools Stories [here](#), [here](#), or [here](#). Do we lock down those young people every year for seasonal flu? Destroy a massive number of businesses, lives and educational opportunities each year for the flu? What I would like to see, rather, is a graph comparing the rate of literacy or math skills paired against the salaries and bloated pensions of the school superintendents (see [here](#) for salary details; this does NOT include all their perks, like working nine months a year, bloated retirement pensions, all kinds of sick days, two weeks off at a Christmas they don't celebrate, etc.). [The Annals of Internal Medicine \(Annals of Internal Medicine September 2, 2020 DOI: 10.7326/M20-5352\)](#) added also their figures showing the relative innocuousness of the virus, stating "*the overall noninstitutionalized infection fatality ratio is 0.26%. People under the age of 40 have a mere 0.01% risk of dying from the infection.*" So, 99.7% survive, which includes all those seriously sick folks, those with serious co-morbidities, extremely low Vit. D., etc. And doesn't include, of course, all those that have died due to missed heart, cancer, diabetes etc. appointments, nor all the suicides, divorces, ruined careers and finances, ad nauseam.

[Another study shows](#) similar numbers, where, based on an R naught factor (infectivity rate) of 2.5, children between the ages of 1 and 19, if infected, are only at a .00003 risk of dying. For young and middle-aged adults, ages 20 – 49, the risk of dying is still slight, approximately .0002, and those 50 to 69 is 0.005. In contrast, Ebola had around a 50% death rate. And in fact, according to the [National Safety Council, your chance of dying in a car accident is 1 in 107.](#) But while at it, let's also look at other odds of dying (admittedly over a lifetime) that far outstrip Covid, per the NSC: Opioid overdose 1 in 92; falling? 1 in 106. We only start to get to Covid-like numbers once we get to drowning, 1 in 1,128, choking on food, 1 in 2,535 and dying of sunstroke, 1 in 8,248. I am still waiting for Dr. Fauci to solemnly advise us to quit taking baths, going out in the sun, and for Heaven's sake, *wear a mask while eating so you don't choke on food!* The [Insurance Information Institute has a similar list,](#) if you wish to check another source. (Yes, I actually *conduct* more verification than the fake news.) But one further question must be asked: *What, exactly, would the death rate be if people kept their vitamin D level above 40 hg/ML? What if people used zinc ionophores like insanely cheap, health food store bought quercetin or the EGCG in green tea along with a doctor recommended dose of zinc? What would the death rate be if we could have used hydroxychloroquine which, Dr. Harvey Risch, professor of epidemiology at Yale University, says would have saved 75 to 100,000 lives if it hadn't been banned simply due to an insane hatred of Trump?* Is the hatred of left so vitriolic that they will let thousands die all to satiate their hate?

Chris Woolams, the British biochemist cite elsewhere in this paper, [then asks the million dollar](#) (or, I guess with all the big bucks involved, the trillion dollar question: “*the CEO of Pfizer says we will need a jab every year. What has Pfizer also told us: Does the Pfizer jab mean I can't catch Covid? No. Does the Pfizer jab mean I won't end up in Hospital with Covid? No. Does the Pfizer jab mean I won't die from Covid? No. Does the Pfizer jab mean I can't pass the virus on? No. For goodness sake! What does it do? If I have the jab, my symptoms will be less. Great. Already the UK Government are talking about a big new wave of Covid cases in the Autumn. Hang on. You have done a great job vaccinating half the country, if your Press Releases are to be believed. If the vaccines really delivered, why would they not confer herd immunity?*

I also personally watched Dr. Bill Bennett, former Secretary of Education, state on Fox News that for every 1% rise in unemployment, there are 10,000 suicides. Unemployment at one point, per the Federal Reserve Bank of St. Louis, was estimated to reach 32.1% - whereas in the Great Depression, the highest it got was 24.9% This does not count those that will die of cirrhosis in 10 years due to those who started drinking again, those who die in 5 years due to getting back on opioids, the massive number of divorces that will accrue (in many cases shortening lives), and children whose educations have been seriously damaged, etc. *It may well be that we have killed more from the lockdowns when all is said and done, by far, than Covid.* Recently, [there have been six times more teen suicides in Cook County than Covid deaths,](#) where isolation is thought to be a major contributing factor, and somewhere around [25% of our young have considered suicide due to the lockdowns.](#) Cook County (Chicago) also reported a staggering doubling of opioid fatalities during the stay at home period as compared to the 100 week period 2018 – 2019... then, as if there were any doubt, when the lockdown was lifted the number quickly declined. The report, published in JAMA Insights April 23, 2021, by

Northwestern University researchers and Dr. Ponni Arunkumar with the Cook County Medical Examiner's Office — “*found that opioid overdose fatalities nearly doubled during the stay-at-home order compared to a 100-week period in 2018 to 2019, rising from 23 deaths per week to 44*”.

Here are the specifics:

“*Researchers analyzed weekly opioid overdose deaths for four different time periods:*

- *100 weeks from January 5, 2018, to December 3, 2019*
- *December 4, 2019, to March 20, 2020 — the 15 weeks prior to the stay-at-home order*
- *March 21, 2020, to June 5, 2020 — the 11 weeks during the stay-at-home order*
- *June 6, 2020, to December 23, 2020 — the 29 weeks after the order was lifted*

In 2018 and 2019, Cook County had already recorded high levels of opioid-related overdose deaths, the researchers noted, with a disturbing increase beginning in late 2019 and early 2020. During this period, 4,283 opioid overdose deaths occurred, with a mean of 23 deaths per week during the initial 100-week period.

This increased to a mean of 35.1 per week in the 15-week period prior to the pandemic, which was followed by “an even more pronounced increase during the 11-week stay-at-home order: 44.1 mean weekly deaths. When the lockdown was lifted, the number of weekly deaths quickly declined and then began to creep up again near the end of the 29-week period, settling at 32.7 deaths per week.”

“Although deaths have declined below the peak weekly numbers seen during the stay-at-home period, opioid overdose deaths following the stay-at-home period remain elevated above pre-2020 levels,” the researchers noted, suggesting that the pandemic took a toll on those at risk of opioid overdose and death.”

Chicago alone? Hardly. [In NY, the UK's Daily Mail reported in May:](#) “*In Times Square, the most densely tourist-populated place in the United States, a mentally disturbed man known as Mr. Kim begs cops to kill him. ‘I want to die. You have a gun? Shoot,’ he pleads. After the officers demur, he picks up a plank of wood and starts smashing it against the Pele soccer shop... in 2021, almost every type of violent crime is on the rise in New York City. According to recent figures from Compstat, the NYPD’s data gathering unit, crime is up 30 percent city wide.*”

Granted some of this is due to the Venezuela-ization of NYC by the Marxist mayor, but the NY lockdown is a major part of this by both reducing human contact and destroying business. “ Per ABC News ABC News April 15, 2020, “*Jacksonville, Florida had a 20% increase in overdose emergency calls in March 2020. Four counties in New York reported a rise in overdoses, while*

Columbus, Ohio, also had a surge in overdose deaths, including 12 over a 24-hour period the first week of April." Epoch Times (the new "newspaper of record" in my opinion) had as its lead story May 26, 2021 Mother Loses Son to Overdose, Warns of Impact of Pandemic, quoting her as saying "I think he was honestly trying to numb that feeling of being isolated." Mr. Fauci must be proud. One wonders what he might tell the God he is going to be meeting in the not-too-distant future.

And in Australia, out of just one of a thousand and one examples around the world, in uber-locked down Victoria, Aussie [7 News reported in May 2021](#) "Victoria's seven-day lockdown leaves experts bracing for spike in domestic violence, mental health calls." No need go into details – they are the same in the antipodes as they are here. They would lock down the penguins in Antarctica and the polar bears – whose numbers have been increasing by the way, with *five times as many as 70 years ago* – in the Arctic if they could.

Part of the issue is that for those addicted, they depend on face-to-face care – as do a massive number of other support groups, which are not adequately replaced by Zoom calls. And of course, others went from opioids to even more dangerous drugs caused by anxiety, isolation, job loss, depression and more. The National Center for Health Statistics (NCHS), in partnership with the Census Bureau, set up an experimental data system known as the Household Pulse Survey.⁷ In all, from May 7 to May 12, 2020, 34.4% of adults reported symptoms of anxiety or depression, while 30% reported signs of anxiety and 24.1% reported symptoms of depression - see [U.S. CDC, National Center for Health Statistics, Mental Health, Household Pulse Survey](#). People may be using opioids who have depression as a form of self-medication for social or emotional pain. The number of those who misuse opioids [were as high as 12 million prior to the ill-advised lockdown, with 40.5 million people worldwide struggling with opioid dependence, or 510 cases per 100,000](#) people. Unknown is how many seek out even more dangerous drugs when their regular "fix" is either not available, or a greater high is needed due to the isolation. And how many have relapsed? How many simply have turned to alcohol for the first time, or relapsed there? And the use is widespread: [insurance claims data from 2016 and 2017 reveal 60% of children between the ages of 1 and 18 with private insurance filled one or more opioid prescriptions after surgical tonsil removal](#), while [dentists wrote 18.1 million prescriptions for opioids in 2017, as the drugs are frequently prescribed for wisdom teeth extractions](#)

The Pulse Survey also reports from May 7 to May 12, 2020, 34.4% of adults reporting symptoms of anxiety or depression, while 30% reported signs of anxiety and 24.1% reported symptoms of depression. US News and World Report told us May 27, 2020, that "*more than 40% of adults in Illinois, Louisiana, Mississippi and Missouri, as well as Washington, D.C., reporting depression or anxiety symptoms. Black and Hispanic adults also reported anxiety or depression more often than whites or Asians, and women, younger adults and people with lower education levels were also more likely to be affected.*" So, perhaps Fauci and others can tell us: do black lives matter

Incidentally, let's apply these numbers to, say, gun use and see how the government responds. Oh. And has anyone even talked about all those missed or delayed appointments for cancer screenings, diabetes treatment, delayed dialysis and more? Or are these folks chopped liver to Fauci, the WHO, and their minions? In fact, the Well Being Trust (WBT) and the Robert Graham Center for Policy Studies in Family Medicine and Primary Care, at [Well Being Trust, Projected Deaths of Despair During the Coronavirus Recession](#), estimated that up to 75,000 people may die during the COVID-19 pandemic from drug or alcohol misuse and suicide.

[Quoting from Mercola at length on the issue of despair, suicide and Covid lockdowns](#), the facts are stark:

"A 2019 study in the Medical Care Research Review journal looked at the effects of state-level economic conditions — unemployment rates, median house prices, median household income, insurance coverage and average hours of weekly work — on drug overdose deaths between 1999 and 2014.15 According to the authors:

'Drug overdose deaths significantly declined with higher house prices ... by nearly 0.17 deaths per 100,000 (~4%) with a \$10,000 increase in median house price. House price effects were more pronounced and only significant among males, non-Hispanic Whites, and individuals younger 45 years.'

'Other economic indicators had insignificant effects. Our findings suggest that economic downturns that substantially reduce house prices such as the Great Recession can increase opioid-related deaths, suggesting that efforts to control access to such drugs should especially intensify during these periods.'

An earlier investigation, published in the International Journal of Drug Policy in 2017, also connected economic recessions and unemployment with rises in illegal drug use among adults. Twenty-eight studies published between 1990 and 2015 were included in the review, 17 of which found that the psychological distress associated with economic recessions and unemployment was a significant factor. According to the authors:

'The current evidence is in line with the hypothesis that drug use increases in times of recession because unemployment increases psychological distress which increases drug use. During times of recession, psychological support for those who lost their job and are vulnerable to drug use (relapse) is likely to be important.'"

In [Pandemic May Lead to 75,000 'Deaths of Despair'](#) a report by the Well Being Trust (WBT) and the Robert Graham Center for Policy Studies in Family Medicine and

Primary Care, it was estimated that up to 75,000 people may die during the COVID-19 pandemic from drug or alcohol misuse and suicide. These “deaths of despair” are expected to be exacerbated by three factors already at play:

- *Unprecedented economic failure paired with massive unemployment*
- *Mandated social isolation for months and possible residual isolation for years*
- *Uncertainty caused by the sudden emergence of a novel, previously unknown microbe*

In order to come up with their 75,000 figure, the study used data on deaths of despair from 2018 as a baseline, projected levels of unemployment from 2020 to 2029 and then used economic modeling to estimate the additional number of deaths annually. Nine different scenarios were tested, ranging from quick recovery to slow recovery.

In the best-case scenario, 27,644 deaths of despair were estimated while in the worst-case example, 154,037 deaths could occur. While 75,000 was deemed to be “most likely,” the researchers noted, “When considering the negative impact of isolation and uncertainty, a higher estimate may be more accurate.”

“Undeniably policymakers must place a large focus on mitigating the effects of COVID. However, if the country continues to ignore the collateral damage — specifically our nation’s mental health — we will not come out of this stronger,” Benjamin F. Miller, PsyD, chief strategy officer of WBT, said in a news release.

A commentary by Dr. Jeffrey A. Lieberman, a psychiatrist with Columbia University’s department of psychiatry, similarly suggested a mental health crisis is looming. “The sobering reality is that high-quality mental health care is not available to most people,” Lieberman wrote. “This lack of strategy and access is especially concerning amid disasters such as COVID-19, which can cause considerable psychological trauma.” (See full article on this at <https://www.psychiatrictimes.com/view/psychiatric-ramifications-covid-19-pandemic>)

As mentioned, prolonged isolation only exacerbates the issue. “Social isolation is one of the factors that leads [people with substance abuse disorder] ... to take drugs, and social isolation leads them to relapse, and the social isolation leads them to continue taking them.” With weeks of extended isolation already logged for most Americans, some communities are already reporting a rise in drug overdose deaths. Jacksonville, Florida, for instance, had a 20% increase in overdose emergency calls in March 2020. Four counties in New York State also reported a rise in overdoses, while Columbus, Ohio, had a surge in overdose deaths, including 12 over a 24-hour period the first week of April.

Dr Nora Volkow, the director of the government's National Institute on Drug Abuse [told ABC News](#) that whether overdose deaths are increasing across the U.S. is unknown, as Volkow noted that with COVID-19 shutdowns, collecting reliable data is difficult. However, a spokesperson for the U.S. Centers for Disease Control and Prevention told ABC News that officials are "aware of the concerns involving COVID-19 and drug overdoses and that it could affect some populations with substance use disorders."

If you want to do some further research on this, here are some places to start, using the Great Depression experience as a launch point:

Suicide rates averaged 12.1 per 100,000 people in the decade prior to the Depression, then jumped to an alarming 18.9 in the year of Wall Street's crash.



A more recent [New Zealand study from 1991](#) published in the British Medical Journal also shows similar figures, [as does this 1985 British Medical Journal article](#) Vol 291, No. 6508, Nov. 30, 1985). For a full complement of peer-reviewed studies on what the lockdowns have done for suicide rates – and just to add fuel to the fire – see the 2015 [World Economic Forum article](#), another [British study from 1984 in the Journal of Epidemiology and Community Health](#), or this [PBS article from 2013](#). Of course, in uber-locked down Australia, March through mid-June, 2021, there have been [50% more](#) deaths from suicide than from Covid-19.

Most staggeringly, the [American Inst. for Economic Research reported Mar. 17, 2021](#) that we have now reached the point where [we have more Covid suicides than Covid deaths in children](#). Stop and read that sentence again... then take a look at the link above. Where is Nancy Pelosi's call "It's for the *children!*". Then recall that in addition to that, we have deprived one third of our population of educational, emotional and social development without their permission or consent, where Covid accounted for barely 1.2% of all deaths in those under 25. See that solid red line just above the "0" line below? That represents the OTHER 98.8% of deaths in that age group that had nothing to do with Covid. Simon Black of Sovereign Man puts it more baldly in his May 4, 2021 email:

"Millions of children simply stopped learning at the age when their minds develop more rapidly than at any other time in life. Sheepish bureaucrats hid behind Zoom classes as an adequate substitute for real learning and human interaction, though hardly a thought was given to the cost versus benefit. It's hard to fault anyone for the decisions they made back in March or April of 2020. There was no data. And

plenty of people took the most conservative approach. But by summer 2020, there were mountains of data to support an informed decision. Consider, for example, precisely 54 children in the Land of the Free have died from COVID (according to CDC data through April 28). Given that there have been roughly 4 million confirmed COVID cases among children, this implies a survival rate of 99.999%. For kids, even the Chicken Pox is more fatal, not to mention a variety of other common illnesses ranging from the flu to strep throat.” Oh, and did you know, according the WHO, diarrhea kills 525,000 kids per year, a lot of it due to the rotavirus – massively more likely than Covid? Lord Protector Anthony Fauci, noted back in 2009 during the Swine Flu epidemic that “we have already 76 children dying from the 2009 H1N1 virus, and it’s only the beginning of October.” Yet his eminence did not demand schools close. And the CDC specifically recommended NOT closing schools. Fauci also stated then, “you can’t isolate yourself from the rest of the world for the whole flu season.” Yeah... I guess until it is part of the Great Reset gambit... then you can close the whole economy down for an epidemic of stubbed toes.

Long story short, compared to 2018 and 2019 deaths per 100k, 2020 saw one extra death among those under age five, an additional 1.5 deaths among those aged 5 to 14, and a whopping 23 additional deaths among those aged 15 to 24. AIER adds that “Between March and August the National Alliance on Mental Illness HelpLine reported a 65% increase in calls and emails. The Trevor Project — which targets suicide prevention among LGBTQ youth — saw double its usual call volume. The jump in helpline calls hadn’t let up by the end of 2020: in November Crisis Text Line received 180,000 calls — its highest volume ever, and an increase of

30,000 from the previous month. Over 90% of those were from people under 35... In August 2020, FAIR Health found a 334% spike in intentional self-harm claims among 13–18 year olds in the Northeast compared to the same month in 2019. Nationally self-harm medical claim lines nearly doubled for this group in both March and April, while claim lines for overdoses as a percentage of all medical claim lines increased 95% and 119% percent respectively. Indeed, during the first eight months of 2020, suicides in Los Alamos (NM) tripled while Fresno (CA) numbers jumped 70% in June 2020 compared to the same month the previous year. Even the CDC acknowledges a 31% increase in the proportion of mental health-related ER visits for 12 to 17 year olds between March and October last year compared to the previous year."

Worse... [as reported by Foundation for Economic Education, at FEE.org](#), a research organization dedicated to documenting the consequences of government pandemic interventions, Collateral Global, released a [May analysis](#) reviewing the research on how lockdowns will affect children's prospects. The results are both staggering as well as disgusting. To wit: "*The COVID-19 pandemic and restrictive mitigation policies have forced millions of children worldwide into poverty, with devastating effects on their access to education, nutrition, shelter, sanitation, and overall likelihood of survival,*" the Collateral Global research team [reports](#). Per the report:

- Global child poverty has now increased 15% to hit 1.2 billion children living on less than \$2/day
- Disruptions to access to healthcare, vaccinations, nutrition, etc. could mean that up to 1.2 million additional children die before their fifth birthday
- A whopping 7 to 9.7 million children who missed school during the pandemic will never return
- Up to 100 million children will never reach basic reading proficiency



Yes, it is true that some of this fallout couldn't have been avoided given the pandemic. But—especially for children at extremely minimal risk of death from COVID-19—much of it traces back directly to government restrictions that closed schools, limited healthcare access, and closed economies. As noted elsewhere in this paper, *children under 21 have 3–4 times LESS risk of dying from Covid than regular seasonal flu!*

Of course studies have shown lockdown orders have [little to no impact on the spread of COVID-19](#) and the fact that the virus [largely spreads at home](#), but presumably that, along with the hundreds of millions of human children being impacted, is of little consequence to the Great Reset folks behind this gambit.

Dr. Mercola [puts it all in a nutshell](#), that while of a certainty we *do* want to protect the truly vulnerable, per [the Annals of Internal Medicine](#), the average age of death from COVID-19 is ~76.9, according to one study or 82, according to U.K. government data cited by Jonathan Sumption in the UK Telegraph, Feb. 15, 2021. Of a certainty, every life is precious (except, of course, if your name is Cuomo or Whitmer.... then, bumping off granny early by putting her in a nursing home when you have an empty Javits Center, or a vacant US Navy hospital ship, a la Obamacare architect Ezekiel (“[Why I Hope to Die at 75](#)” Emanuel, brother of Rahm “Never let a crisis go to waste” Emanuel,”) these ages of death are still right around the average age of death from any cause anyway, and therefore not an outrageous threat to public health as, say, losing a fully healthy 20 year old). Yet, says Mercola *“The public willingly relinquishes the freedom to live a normal life, somehow oddly convinced that by trading in their freedom, people at the end of their life will be spared the pain of death. They won’t. None of us will. The inevitabilities of life — which include uncertainty, moment-to-moment risk and the surety of death — demand that we not require people to cease living in order to “save” others from the ramifications of ill health, regardless of their age. It’s as inhumane as it is illogical. Rather, the answer, if we really want to protect the masses, is to educate and promote healthy living at all stages of life. Improving your health through a healthy lifestyle, sunshine, fresh air and real food, is the best way to protect the most people. Quarantining and shunning human interaction are probably the worst things you can do for yourself and society at large.”*

Mercola also discusses, [in another article](#), that “A recent analysis compared states with restrictive interventions (lockdowns) against those with less restrictive strategies and found lockdowns are not an effective way to reduce the spread of COVID-19; Lockdowns have forced 60% of businesses to close – in fact, [Technocracy News informs us that](#) “according to a September 2020 economic impact report4 by [Yelp](#), 163,735 U.S. businesses had closed their doors as of August 31, 2020, and of those, 60% — a total of 97,966 businesses — were permanent closures. As noted by Senger “That ‘leaders’ across the world transformed into tyrants, believing they had a right to bankrupt their subjects, is the core evil of lockdown.” Of course, the top five richest people increased their net worth by 26% between March 13 and June 17, 2020. And since the beginning of the pandemic, the collective wealth of 651 billionaires in the U.S. rose by more than 36% (\$1 trillion).⁸ The assets of these 651 billionaires is now nearly double that of the combined wealth of the least wealthy 165 million Americans.” [Yelp tell us 163,735 businesses closed as of Aug. 31, 2020 with 60% permanent, totaling 97,966](#). Or think of livelihoods destroyed. [The number of Black-owned businesses that have closed down](#)

permanently during the pandemic is substantially greater than the number of white firms and companies which have been forced to close. And as part of the Great Reset, which is basically large companies taking over everything in conjunction with government (also known, technically, as fascism, as originally defined by Mussolini) between March 18, 2020, and April 12, 2021, American billionaires' wealth increased by \$1.62 trillion — 55% — from \$2.95 trillion to \$4.56 trillion. One-third of the total wealth gains by billionaires since 1990 occurred in the last 13 months. Then compare this to the small businesses closed. And of course, there are 40 new billionaires created with ties to companies working with Covid, while the faux vaccines alone have created nine new billionaires. But not to worry! Us poor serfs get a measly stimulus cheque of a thousand or two, which apparently is meant to keep us from taking to the streets with pitchforks. Frank Clemente, executive director of Americans for Tax Fairness, put it plainly in Children's Health Defense December 14, 2020 "Never before has America seen such an accumulation of wealth in so few hands."

Worse, during the lockdown there has not only been an increase in the number of suicides as noted above, but also child abuse, rape and domestic abuse; The drug overdose epidemic has grown more complicated and deadly during the lockdowns; More than 6,000 medical practitioners and medical and public health scientists signed a petition to halt the lockdowns citing 'irreparable damage'" Human Rights Watch tells us over 1.5 billion kids are out of school, with untold impact to their future. In Nov., 2020 the UK's Guardian reported many kids are regressing physically and mentally due to the lockdowns, and the Washington Post noted scholastic achievement gaps, as well as early literacy, had declined sharply. The Economist added that kids over the age of 10 have cut physical activity in half. In fact, the night before this paragraph was written, I talked with a young mother whose 12-year-old was in for counselling for suicide ideation, telling her there "was no reason to even get dressed in the morning," and later that same evening a family member told me her son had no ability to do his usual exercise regimen of hockey, basketball, golf (courses locked down, too!) etc. (This was followed by a business associate telling me she had just spent \$25,000 on sinus surgery brought on by mask wearing).

Perhaps in lieu of lockdowns, we might have just...ummm...followed the science. Natural Health published a study by researchers at Tufts University, using – as reported by Natural Health 365 –

"...statistical modeling and mathematical simulation techniques to estimate the number of hospitalizations that could have been prevented in the United States if people didn't have the following four major cardiometabolic diseases. These diseases include obesity, diabetes, heart failure, and hypertension. Based on data they compiled from the U.S. Centers for Disease Control and Prevention's Coronavirus Disease 2019 – Associated Hospitalization Surveillance Network database, the COVID Tracking Project, and nationally represented data from a recent National Health and Nutrition Examination Survey, the researchers found that nearly a third of all COVID-19 hospitalizations as of November 2020 was due to obesity, about a quarter was due to hypertension and diabetes, and around 12 percent was due to heart failure, a form of heart disease. The authors conclude, 'A

substantial proportion of U.S. COVID-19 hospitalizations appear attributable to major cardiometabolic conditions.” They did not report on those low in Vit. D, City Journal reported “There was a sharp decline in visits to emergency rooms and an increase in fatal heart attacks due to failure to receive prompt treatment. Many fewer people were screened for cancer. Social isolation contributed to excess deaths from dementia and Alzheimer’s. Researchers predicted that the social and economic upheaval would lead to tens of thousands of “deaths of despair” from drug overdoses, alcoholism, and suicide. As unemployment surged and mental-health and substance-abuse treatment programs were interrupted, the reported levels of anxiety, depression, and suicidal thoughts increased dramatically, as did alcohol sales and fatal drug overdoses. The number of people killed last year in motor-vehicle accidents in the United States rose to the highest level in more than a decade, even though Americans did significantly less driving than in 2019. It was the steepest annual increase in the fatality rate per mile traveled in nearly a century, apparently due to more substance abuse and more high-speed driving on empty roads. The CDC counted about 345,000 deaths last year in which Covid-19 was the “underlying cause” (nudge, nudge, wink, wink). Even if you add the deaths in which the virus was a “contributing cause,” bringing the total to nearly 380,000, that accounts for only three-quarters of the excess mortality. Given that the total number of excess deaths, by the CDC’s calculation, was about 510,000 last year, that leaves more than 130,000 excess deaths from other causes. How many of those 130,000 people in America were killed by lockdowns? No one knows, but the number is surely large, and the toll will keep growing this year and beyond. The United States will experience more than 1 million excess deaths in the United States during the next two decades as a result of the massive ‘unemployment shock’ last year, according to a team of researchers from Johns Hopkins and Duke, who analyzed the effects of past recessions on mortality” Is there any way the lockdown hasn’t killed?

Has the Covid “fear advertising” worked? Well, there is a long history of this gambit, starting with this [ad telling us](#) “More doctors in all branches of medicine prefer Camel cigarettes than any other.” (Another ad [here](#)). Stupid? **Just think how a decade or two down the road they will look at us with our global warming scam or fear of a virus that, as noted above – and to repeat again - Dr. Jay Bhattacharya, M.D, Ph.D, Stanford Univ. Medical School, said in Imprimis, Oct. 2020, that for the 0 – 20 range, has a fatality rate two three times LESS than seasonal influenza.** IN May 2021, Simon Black of Sovereign Man found the same, writing “... we have even more data, where precisely 54 children had died as of April 28, 2021. Out of 4 million confirmed cases among kids, this implies a survival rate of 99.999%. Children are more likely to die of diarrhea than Covid 19, says Black. Dr. Mandy Armitage, MD, discusses the nuances of the overall fatality numbers, flu vs. Covid, as of Aug 2020 [here](#). It is not a simple apples to oranges to comparison in her opinion. The actual mortality stats for your review are at https://www.cdc.gov/nchs/nvss/deaths.htm?CDC_AA_refVal=https%3A%2F%2Fwww.cdc.gov%2Fnchs%2Fdeaths.htm But of course, even the CDC was forced to admit that 94% of Covid deaths were people who died with the virus, not from it.

Heck, Fauci might just have well recommended Camels along with his masks. Edward Bernays (1891-1995), nephew of Sigmund Freud, and pioneer in public relations & modern propaganda, showed how the illusion of fake choice to manipulate the masses is done, which you can learn about [here](#) (11 min). In short, the elites create, and then prey on, fear. The whole game is summarized [here](#), but as one example, the Scientific Pandemic Influenza Group on Behavior (SPI-B), a subcommittee that advises the Scientific Advisory Group for Emergencies (SAGE) in the U.K. And they should know, because they advocated for it, and now say it was a regrettable mistake. As reported by The Telegraph, May 14, 2021. And of course, as Laura Dodsworth wrote in her new book *A State of Fear: How the UK Government Weaponised Fear During the Covid-19 Pandemic*, "giving out contradictory recommendations and vague instructions is being done intentionally, to keep you psychologically vulnerable." And psychiatrist Dr. Peter Breggin adds that by layering confusion and uncertainty on top of fear, you can bring an individual to a state in which they can no longer think rationally. Once driven into an illogical state, they are easily manipulated. Ask yourself: What is behind the messages of fear and conflicting "information" the bought and paid for media have in mind? Recall that all the major news outlets only have a half dozen major corporate owners.

There is a war on for your freedom, your health, your mind and even your very life. And it is all between two competing visions, as Fleet Street letter wrote two decades ago, and as summarized by Raoul Milhado [in 2020](#), "The global economic transformation now faces the main question: What to choose — centralization or decentralization?"

Here is Fleet Street, my comments in parentheses):

There are two major traditions in Western political thought. The first is Aristotelian, logical, rational, centrist, mechanistic. You concentrate power and truth in the centre and apply it outward, shaping the world according to plan.

This was the guiding principle of the Roman Empire. It evolved into the Holy Roman Empire and the Church of Rome. Except for Switzerland, it has dominated politics on the continent ever since. Most recently, it has morphed into the European Union.

The principle is simple – smart people can figure out how to run things, and should be allowed to do so. This was the idea behind Hillary Clinton's health care task force (then Obamacare, and now Biden's Build Back Better... or Worse, as the case may be as well as Agenda 2030), as well as Japan, Inc. and even Adolph Hitler's National Socialist Germany. It has animated nearly every politician (each one of whom, as Garrison Keillor notes about Lake Woebegone children, are above average) in this century.

But there is another tradition that is much less well understood. It is the tradition of the Roman Republic... of English common law... of Adam Smith and Emmanuel Kant... of Austrian School economists such as Ludwig von Mises and Friedrich Hayek and of pre-Rooseveltian American (and I might add Martin Luther). It is organic, rather than mechanistic – the tradition of tradition, based on the recognition that people, no matter how smart, cannot replace thousands of years of accumulated experience (remember the “best and the brightest” who led the Vietnam war? Or, wonder where the radical homosexual power move is going to end?)

Experience is embodied in the evolved systems of values, customs, rules and traditions that people use to order and give meaning to their lives. A free market and a free society allow people to express these preferences, as well as allowing the process of social and civil evolution to continue. This tradition, in other words, is neither liberal nor conservative in the modern sense, but anti-political. Indeed, it is often seen as “anti-intellectual” because it denies the authority of intellectuals to tell the rest of us what to do (through the political process).
