



- As of 1530hrs on 2022-02-20, the Ottawa Police Service (OPS) reports 191 demonstrators arrested, 389 charges laid and 79 vehicles towed.¹²
- Many events were planned across the country. Some were cancelled or postponed, and others materialized without violent incidents.

Operational Update for Commissioner Lucki's Briefing with Minister Blair Sunday, February 20, 2022

Ottawa

- Since the beginning of the operation, 233 arrests have been made, and over 74 vehicles towed from the area (as of 9:32 PM Saturday, February 19th, 2022).
 - Stats from Saturday, February 19, 2022 only 110 arrests, 36 heavy tows completed.
- There is currently a 7-day hold on towed vehicles before they can be picked up by owners.
- As of 7:33 PM, Wellington Street has been cleared (92 vehicles to start).
- Fencing installed: Elgin Street to bay Street along Sparks Street. Parliamentary access at Kent Street.
- Three uniform checkpoints established: Kent/Sparks, Kent/Bay, and Bay/Wellington
- Fencing unable to be completed beyond Kent Street (West) until morning due to logistical issues.
- 50 cement barriers delivered for continued secure zone strengthening today.
- As of 9:32 PM approximately 150-200 people in the crowd respecting the fence line.
- As of 5:17 PM 21 vehicles and 2 RVs on Sir John A McDonald Parkway tow trucks en route with OPS escorts to tow vehicles should occupants refuse to leave.
- Information has been provided that some vehicles are leaving remaining sites willingly.
- Significant misinformation is circulating on social media, including that police have beat up protesters, that police have deployed tear gas, etc. Ottawa Police has been quick to quash misinformation via their Twitter feed, providing accurate, up-to-date information.
- Portage and Chaudière bridges are open in the Quebec-bound direction only.
- Occupants at Coventry are starting to dismantle and advise they need 2-3 days to vacate. As of 7:33PM there were approximately 50 vehicles in the Coventry north parking lot.
- Information that they may be relocating to Kenny U-Pull at 6638 Bank Street near the town of Metcalfe.
- Convoy supports continue to gather at ANTRIM truck stop in Arnprior despite the owner conveying his disapproval for protesters to use this site.
- As of 3:00 PM, it was reported that the Supply Convoy from Fort McMurray was in Arnprior. The OPS is trying to discourage them from going to Ottawa.
- Last night, convoy supporters convening at HERB's Gas Station (Embrum) remain there likely due to inclement weather.

Ontario (as of 6:00PM February 19, 2021)

- Ambassador Bridge (Windsor) POE open and flowing freely in both directions.
- Bluewater Bridge (Sarnia) no passenger vehicles or commercial traffic delays.
- Highway 402 has reopened.

Toronto:

- TPS has noted an ongoing small protest taking place at Queen's Park. As of 1400, there were approximately 500 participants.
- A possible protest in solidarity with Ottawa residents is scheduled at Toronto City Hall on Sunday, February 20, 2022.
- o TPS has closed University Ave between Dundas and College.
- TPS continues to have Queen's Park Circle (between College St. and Bloor St.),
 Grosvenor St. (between Queen's Park Circle and Bay St.) and Wellesley St W.
 (between Bay St. and the entrance to the U of T campus) closed to prevent possible protest vehicles from attending the area.
- Cornwall additional staffing at all POE's for the weekend. No activity during the day and none expected at this time.
- Thousand Island nothing to report
- Johnstown nothing to report
- Queenston/Lewiston Bridge no demonstrators/demonstrations located.
- Peace Bridge disorganized single vehicles/small groups in the area. No issues. High visible police presence. PLT has cleared the area.
- Thunder Bay information suggests that a demonstration may occur in the near future a border crossings nearby.





- FARFADAA insignia: The "f*ck you" symbol is used by FARFADAA a splinter group of La Meute which is an Islamophobic anti-immigration Quebec nationalist group
- Gadsden Flag: "The Don't tread on me" Gadsden flag originated in the American revolution, and since then, has become a popular symbol for right-libertarians and the far right
- WWG1WGA: QAnon slogan meaning "Where we go one, we go all" alleging a pedophile ring is trying to take down Trump. Writer's comment: It is believed that this was observed on

COVID 19 has amplified the grievances held by ideologically motivated groups and individuals and the pandemic has served as an opportunity to promote their propaganda and ideology.

Dynamic factors continue to cause concern and may be exacerbated with police enforcement. The potential for violence by a lone actor or fringe group cannot be discounted as protesters remain in Ottawa.

While it is noted that not all individuals participating in "Freedom Convoy 2022" protests adhere to ideologically motivated violent extremist (IMVE) thinking, the presence of IMVE adherents have been noted in a few instances in relation to these protest events:

- In Ottawa, one truck participating in the convoy was found displaying a THREE PERCENTERS (III%) flag. The Three Percenters were listed as a terrorist entity in Canada in 2021 and have espoused anti-immigration and anti-Islam views in the past. No other references to the THREE PERCENTERS have been noted at convoy protests in recent days and the THREE PERCENTERS have not had visible presence in Canada since being listed as a terrorist entity.
- A few members of the DIAGOLON (adjacent to the PLAID ARMY) movement have also been seen in Ottawa during the convoy protests. DIAGOLON/PLAID ARMY emerged as a memebased, satirical movement online in 2021, sharing anti-government and anti-vaccine/mandate views under the guise of humour. In recent days, prominent members of DIAGOLON/PLAID ARMY have espoused increasingly violent rhetoric opposing vaccine mandates. One member was arrested in January over firearms related offences and has since been seen attending convoy events in Ottawa, frequently warning supporters of imminent law enforcement action against the convoy demonstrations, and denouncing police enforcement of such as illegal. DIAGOLON adherents express desires to form a country based on right-leaning Canadian provinces and US states. Their grievances extend beyond COVID-19 restrictions and are centered on countering "politically correct" culture.
- CANADA FIRST, a white nationalist group, has also been observed in Ottawa. One CANADA FIRST adherent is accused of throwing rocks at the Prime Minister during the election campaign. This same individual has been observed in Ottawa during the convoy.

Outside of the organized IMVE groups, the convoy movement appears to create an ideologically charged environment in which individuals who may hold frustrations towards public health restrictions may feel this is their one chance to express their frustrations. The movement, given its widespread reach, is attracting individuals who may hold IMVE beliefs and may feel emboldened in their views amid the movement's popularity. While the majority of convoy protesters are peaceful and denounce violence, the possibility of a lone actor attack, inspired by ideologically motivated beliefs, cannot be discounted. RCMP K Division (Alberta) recently seized a number of firearms from convoy vehicles at the Coutts AB blockade.

The blockades at international borders are also likely attempts at forming national solidarity with convoy protesters in Ottawa, with the knowledge that affecting critical transportation and economic infrastructure may pressure governments to repeal public health restrictions. Narratives questioning the loyalty and authority of police have also been circulating surrounding this movement in recent days.

We continue to track and analyze these developments and will provide updates as products are finalized.

- There are currently 1184 personnel deployed for the Ottawa Command Assist OPS & Protective, including Public Order Units and Tactical Support Group members.
- Since the beginning of the operation, 191 arrests have been made, and over 74 vehicles towed from the area.

AIM

To provide an update on potential DIAGOLON supporters or sympathizers observed with the movement's founder and leader, Jeremy MACKENZIE /@ragingdissdent2, at the Ottawa "Freedom Convoy" public order event.

KEY FINDINGS

- Based on various social media posts, it is believed that the founder of DIAGOLON, MACKENZIE, was participating in the Ottawa "Freedom Convoy" public order event.
- On 2022-02-02, the RCMP H Division arrested MACKENZIE for firearms offences after executing a search
 warrant at a residence in Pictou, NS. Several restricted firearms were seized and MACKENZIE was released on
 conditions.¹
- Two of the four individuals charged for conspiracy to murder RCMP officers near Coutts, AB, Chris LYSACK and Chris CARBERT, have ties with MACKENZIE.²
- Additional alleged DIAGOLON supporters or sympathizers from the National Capital Region (NCR) may be located through further passive open source information.
- In February 2022, Instagram account "@ragingdissident2" posted pictures of MACKENZIE with several individuals in downtown Ottawa. These individuals may be DIAGOLON sympathizers, but are not corroborated as such.
- On 2022-02-19, @ragingdissident2 posted a leaked conversation of RCMP Musical Ride Employees to his Instagram page.⁴

ISSUE

MACKENZIE and other DIAGOLON sympathizers' presence at upcoming anti COVID-19 health measures or restrictions public order events may pose a risk to public and officers' safety. The DIAGOLON movement reportedly feels that "a civil war is needed to create a new white nationalist state that would run diagonally from Alaska, through western Canada's provinces, trough to Florida." ⁵ DIAGOLON supporters refer to themselves as "Bigots" and their motto is "gun or rope" 6.

ANALYSIS

A few alleged DIAGOLON supporters or sympathizers from the NCR could be identified through open source; however, this information is not corroborated. Online queries uncovered a link between two individuals arrested in Coutts, AB, for conspiracy to murder and @ragingdissident2 also posted pictures on his Instagram account of himself with various individuals while at the "Freedom Convoy" in Ottawa throughout the month of February 2022. Instagram account "@ragingdissident2" is believed to be used and operated by MACKENZIE.

TWO INDIVIDUALS WITH TIES TO MACKENZIE CHARGED WITH CONSPIRACY TO MURDER

On 2022-02-17, CBC News reported that Christopher CARBERT (and Christopher LYSAK both residing in Lethbridge, AB, have been arrested for Conspiracy to murder RCMP officers near Coutts, AB. CARBERT and LYSAK are reportedly known to have ties with MACKENZIE and two DIAGOLON patches were seized during the execution of the search warrants in Coutts, AB.9

CBC News further reported that CARBERT posted numerous videos on his Facebook profile where he repeatedly mentioned that he was "prepared to die in protest of government mandates." 10

On 2022-02-15, the Canadian Anti-Hate Network (CAHN), posted on Twitter that MACKENZIE once called LYSAK the "Head of Security" for DIAGOLON. 12

DEREK HARRISON @zoolander95 AKA Derek Rants

MACKENZIE and HARRISON have reportedly spent the first Saturday (2022-01-29) of the "Freedom Convoy" in a hotel room together. ¹⁴ During a livestream, HARRISON advocated for a January 6th US Capitol riot event to be recreated at Parliament Hill during the "Freedom Convoy". ¹⁵



ALEX VRIEND @ferrymans_toll

On 2022-02-18, MACKENZIE tagged a video made by @theferryman_stoll on Instagram, where VRIEND, was talking about "tow trucks, big rigs and all that stuff" coming to remove the protestors trucks from the area. VIEND further stated "get out as quickly as you can." 18

According to CAHN, VRIEND has become one of the most "outspoken and influential members" of DIAGOLON and is described as a "Holocaust Denier". VRIEND, a draftsman, reportedly travelled across the country since the summer of 2020 in an attempt to unite DIAGOLON members. ¹⁹ CAHN further claims VRIEND espouses violent rhetoric online. They further advise that he is from Ontario but resides in Alberta. ²⁰ The @ferryman_toll Instagram account is private

and cannot be passively accessed. While some posts were made publicly on 2022-02-18,



ALLEGED DIAGOLON SAFEHOUSE NEAR OTTAWA

In addition to exposing some suspected DIAGOLON supporters from the NCR on Twitter on 2022-02-20, also exposed an alleged DIAGOLON safehouse near Ottawa, as pictured below. Although this requires corroboration, claims various DIAGOLON social media streams refer to this location as a DIAGOLON safehouse and a location where the group gets firearm training.⁵⁰
