APPEAL

THE APPELLANT APPEALS to the Federal Court of Appeal, pursuant to s. 27 of the *Federal Courts Act*, from the order of the Federal Court, Russell, J., dated April 24th in Federal Court Docket # T-2010-11 by which the Federal Court struck the entirety of the claim, with leave to amend notwithstanding that the Court ruled that the main issues of declaratory relief were justiciable.

THE APPELLANT ASKS that:

- (a) the order (judgment) of the Federal Court be varied to strike only the portions of the claim struck with respect to the tort and *Charter* claims, with leave to amend *only* those struck portions, and the rest of the claim to proceed, with public interest standing, and jurisdiction in the Court, to adjudicate those portions of the claim ruled justiciable;
- (b) solicitor-client costs and, in accordance with *Native Women's Assn. of Canada vs. Canada* [1994] 3 SCR 627, such further and other relief as counsel may request and this Honourable Court deems just;

THE GROUNDS OF APPEAL are as follows:

- (a) that the learned Justice erred, once finding that the main parts of the claim, namely the declaratory relief sought, in not ruling that the plaintiffs had public interest standing, and the Court jurisdiction, to pursue the declaratory relief ruled justiciable;
- (b) that the learned Justice erred in the face of (a) above, in striking the *entirety* of the claim, and not simply restricting leave to amend to the portions struck with respect to the tort and *Charter* violations of the claim; and
- (c) such further and other grounds as counsel may advise and this Honourable Court permit.
