1. The Defendant denies the allegations stated in the Plaintiff's Claim.
2. The defendant is legally known as [REDACTED]
3. The defendant did some volunteer work organizing events for the plaintiff, during this time, the defendant used her own funds, to later be reimbursed, for expenses related to these events.
4. The transfer of funds from the Plaintiff to the defendant, totalling 1554.00\$ that are attached to the Plaintiff's Claim, one on May 2nd 2024 for the amount of 1,188.00\$ memoed "fees" and a second on July 4th 2024, for the amount of 366.00\$ with no memo, were intended to cover a broader range of expenses
5. The Hamilton Event venue's 50% deposit was 437.50\$ with its total cost being 875\$ along with a 1000.00\$ security deposit. The amounts transferred by the plaintiff do not coincide with these amounts.
6. The Hamilton event venue canceled the rental of its premises itself due to public backlash relating to the plaintiff's event.
7. The Plaintiff still owes money to the defendant for the costs incurred by the Defendant in organizing their events, the latter intends to file a defendant's claim in relation to this matter.

RENTAL AGREEMENT

In consideration of the rents paid by the Lessee to the Lessor and the other covenants contained

herein, the Lessor agrees to rent to the Lessee, the Riverside Exhibition Centre Grand Hall and Commerical Kitchen (hereafter called the "Facility") for a party upon the following terms and conditions:

1.

The rental period will be twelve (12) hours: Wednesday, July 31, 2024, 11:59 am EST through to 11:59 pm EST inclusive (Set up and tear down).

2.

The rent to be paid by the Lessee to the Lessor shall be EIGHT HUNDRED SEVENTY-FIVE DOLLARS (\$875.00) subject to the Booking Deposit, Rental Cancellation, and Event Rescheduling Policy.

3.

If waste exceeds dumpster, lessee will be charged for additional pick-up and tipping fee.

4.

The Lessee shall be responsible for providing washroom supervision, and event security.

5.

The Lessee shall leave the Facility in a clean and tidy condition or will be billed for clean-up. Tables and chairs must be returned to original storage area.

6.

The lessee agrees to assume full responsibility for the character, acts, and conduct of all persons admitted to the facility; no person shall be allowed in any part of the building other than the area contracted in this agreement.

7.

The Lessee shall not be allowed to use the facility before the rental period for preparation and the Lessee shall be completely vacated with one (1) hour(s) following the rental period. Failure to comply with this condition will result in a further charge of ONE HUNDRED DOLLARS (\$100.00) per hour until the facility is vacated and in the same physical condition as prior to the Lessee's use.

8.

The lessee agrees to take all reasonable steps to ensure that the event is carried on in a safe and peaceful manner and to ensure the safety of any persons attending the event.

9.

damaged property of individuals or groups who use or rent the facility.

10.

The Lessee shall be responsible for any damage caused to any part of the facility or Fairgrounds property during the rental period and any period of access allowed to the Lessee, and Lessee shall deposit with the Lessor the sum of ONE THOUSAND DOLLARS (\$1,000.00) as a deposit toward any damage caused to the grounds or grounds property which will be refunded within two weeks of end of rental period if no damage has been caused.

11.

The Deposit (or any unused portion thereof) will be returned, without interest, to the Lessee after the rental is completed if the Caledonia Agricultural Society in its own discretion determines that the facility and its contents have not been damaged, defaced, misappropriated, or altered and the facility and its contents are returned in the same state and condition it was prior to the lessee's rental of the facility. Any cost and expenses which are required to return the facility to the state and condition it was in prior to the lessee's rental which are in excess of the deposit amount will be charged to the lessee.

12.

The lessee agrees not to in any way damage or deface the facility or any of its contents. The lessee shall clean the facility after its use and shall leave the facility in its original state of use and condition of cleanliness. If the facility or any of its contents are damaged, altered, or defaced as a direct result of any act, neglect or default of the lessee or if the facility is left in a state of uncleanness, the lessee shall pay the Caledonia Agricultural Society upon demand such sum as shall be necessary to restore the facility and/or its contents to its pre-event condition.

13.

The lessee may not make alcoholic beverages of any type available.

14.

Consumption of alcoholic beverages will not be permitted anywhere.

15.

The Lessee shall take out a comprehensive policy of public liability and property damage insurance providing insurance coverage in respect of any one accident or occurrence to the minimum limit of TWO MILLION DOLLARS (\$2,000,000.00) for the rental period and shall provide the Lessor with written confirmation of the coverage two weeks prior to the commencement of the rental period. 'Caledonia Agricultural Society' must be named as additional insured on the policy certificate.

16.

The lessee acknowledges and agrees that he/she/it shall assume all risks and be responsible for any and all of its actions of all persons present on or in the facility during the rental term set out in this agreement. The lessee hereby agrees to indemnify and hold harmless the Caledonia Agricultural Society and their respective agents, officers, directors, members, servants and employees from and against all claims, actions, proceedings, suits, losses, damages, injuries or death brought by or sustained by any person or entity, including, but not limited to, all costs and expenses incurred in defending any such claims by the Caledonia Agricultural Society caused by, resulting from or in any way related to the rental, use of occupancy by the lessee of the facility; the negligent actions or omission of the lessee, its members, officers, servants, employees, agents, contractors, invitees or any other person present at the facility or any breach or default of any of the terms of this agreement by the lessee.

17.

The Lessee shall maintain liability and damage insurance for the rental period and shall provide the Lessor with written confirmation of the coverage a minimum of two weeks prior to the commencement of the rental period. The Lessee hereby indemnifies and saves harmless the Lessor, its members, servants, agents and directors and officers from and against any and all claims, losses, demands, actions, and causes of action that arise out of or in connection with the activities carried on by the Lessee during the rental period and any period of occupation or use of the grounds by the Lessee, and shall include any acts by the Lessee, its directors, officers, agents, servants and licensees.

18.

The lessee further agrees that the Caledonia Agricultural Society or any of its officers, directors, members, representatives, agents and employees shall not be liable for any loss, theft or damage to the goods, wares, merchandise or property of the lessee, the lessee's employees, invitees, customers or any other person in or about the facility.

19.

The Lessee hereby indemnifies and saves harmless the Lessor, its members, servants, agents and directors and officers from and against any and all claims, losses, demands, actions, and causes of action that arise out of or in connection with the activities carried on by the Lessee during the rental period and shall include any acts by the Lessee, its directors, officers, agents, servants and licensees.

RIVERSIDE EATERY & VENDING

The Lessor reserves the right to operate their food/beverage concession (The Riverside Eatery and/or Riverside Eatery Scoops) during the rental period outlined in this agreement without financial or other consideration due to the Lessee.

Further, the Lessor reserves the right to operate or make available food/beverage vending machines during the rental period outlined in this agreement without financial or other consideration due to the Lessee.

PEPSI BEVERAGES

The Caledonia Fairgrounds, Riverside Exhibition Centre, and Caledonia Finances Hall exclusively serve PepsiCo beverages (Soda/Soft Drinks, Fruit Juices, Bottled Water, and the like).

The Lessee is free to serve any brand of beverages in the parts of the facility outlined in this agreement, however, only PepsiCo products may be placed in any Pepsi, Aqualina or affiliated PepsiCo branded coolers which may be made available to the Lessee.

KEYHOLDER AGREEMENT

In consideration of the rents paid by the Lessee to the Lessor and the other covenants contained herein, the Lessor agrees to provide keys to the facility described in the Rental Agreement between the Lessor and Lessee upon the following terms and conditions:

1. Keys and fobs are to be made available only to authorized persons.
 2. The Lessee will not loan, transfer, give possession of, misuse, modify or alter any keys, fobs, or alarm codes provided under this Keyholder Agreement.
 3. The Lessee will not cause, allow or contribute to the making of any copies of any keys, fobs, or alarm codes provided under this Keyholder Agreement.
 4. The Lessee will pay to the Lessor a \$50.00 (FIFTY DOLLARS) charge for each replacement key should a key become lost or damaged and/or a \$150.00 (ONE HUNDRED AND FIFTY DOLLARS) charge for each replacement fob should a fob become lost or damaged.
 5. Should a key or fob become lost or damaged, the Lessee will immediately contact the Lessor using the emergency contacts provided.
 6. The Lessee will pay to the Lessor any and all expenses to recode locks and issue new keys and/or fobs if found in violation of this Keyholder Agreement at the Lessors discretion to a maximum of \$1,500.00 (ONE-THOUSAND FIVE-HUNDRED DOLLARS) additional to any fees described in section 4 of this Keyholder Agreement.
 7. The Lessee agrees to return all keys and/or fobs on or before the date agreed upon for each key as listed on page two of this Keyholder Agreement.

BOOKING DEPOSIT, RENTAL CANCELLATION, AND EVENT RESCHEDULING POLICY

A booking deposit of fifty percent (50%) of the total rental fee (less any security or damage deposit) is due at the time of signing the rental agreement. No rental date(s) will be held for more than fourteen (14) days without a signed rental agreement and booking deposit payment.

A booking deposit payment must be paid by cheque, bank draft, or money order payable to 'Caledonia Agricultural Society,' or by e-transfer to manager@caledoniafair.ca, or by Interac Debit at our offices (151 Caithness St. E., Caledonia, ON, N3W 1C2) within business hours posted on the office door.

Any booking deposit made (or a portion thereof, determined by the conditions below) will be non-refundable.

If written notice of cancellation is received from the lessee within fourteen (14) days of signing the rental agreement and making the booking deposit payment, a full refund of any funds deposited will be provided by cheque- payable to the lessee -within fourteen (14) days of receipt of said notice. This government-mandated cooling-off period will not be extended beyond fourteen (14) days from the date on which the rental agreement is signed and the booking deposit payment received.

After fourteen (14) days from the date on which the rental agreement is signed and the booking deposit payment received, written notice of cancellation received from the lessee will result in one (1) of the following conditions being placed on said rental agreement and a booking deposit payment refund will be decided based on the date the cancellation notice is received by the lessor:

1) If written notice is received from the lessee between two (2) years and one (1) year prior to the event start date on the rental agreement, a one-hundred percent (100%) refund of any funds deposited will be provided by cheque- payable to the lessee -within fourteen (14) days of receipt by the lessor, OR the lessee can reschedule the event to any available date within two (2) years of the event start date on the rental agreement without loss of any funds deposited. Should the lessee reschedule, the deposit becomes associated with a new rental agreement for the new event date and will be fully non-refundable after signing the new rental agreement. No further

rescheduling of the event or refund under this policy will be permitted except in extraordinary circumstances as determined by the lessor.

2) If written notice is received from the lessee between three-hundred-thirty-four (334) days and ninety (90) days prior to the event start date on the rental agreement, a fifty percent (50%) refund of any funds deposited will be provided by cheque - payable to the lessee - within fourteen (14) days of receipt by the lessor, OR the lessee can reschedule the event to any available date within one (1) year of the event start date on the rental agreement without loss of any funds deposited. Should the lessee reschedule, the deposit becomes associated with a new rental agreement for the new event date and will be fully non-refundable after signing the new rental agreement. No further rescheduling of the event or refund under this policy will be permitted except in extraordinary circumstances as determined by the lessor.






