Your Honour:

Our firm has been retained by the plaintiff, Dr. Kulvinder Kaur Gill with respect to this matter. The other plaintiff, Dr. Ashvinder Kaur Lamba has retained Mr. Asher Honickman of Jordan Honickman Barristers. Both firms were retained yesterday. We write on behalf of both plaintiffs. We have copied defendants' counsel on this letter.

We understand that superficial cost submissions were received from the plaintiffs' former counsel and that you currently have that cost decision under reserve. These submissions were sent without instructions from our clients, and without their knowledge or consent. They only discovered later that these submissions had been filed, after reading online postings from some of the defendants.

Our clients will therefore be requesting leave to file proper and comprehensive written submissions, which has always been their intention. The Court will appreciate that given the significant amounts requested by the defendants, this issue is very important to our clients.
