NO ONE APPEARED ADJOURNED TO BE SPOKEN COURT

New counsel for the Plaintiffs attended at this case conference arranged to deal with their request to provide supplementary submissions on the subject of costs of the motions heard in this matter.

Counsel for the Defendants did not take strenuous objection to the proposed provision of supplementary submissions by the Plaintiffs but requested that a time limit be placed on such delivery and that the length of such submissions be restricted.

As I indicated at the end of the case conference, I grant the request made by new counsel for the Plaintiffs to deliver costs submissions. Having considered the submissions of counsel, I order that

such submissions be provided within two weeks of today's date and not be subject to any strict page limit. Having said that, I would expect them to be succinct, relevant and not to exceed the length of those provided by the Defendants.

The Defendants are likewise granted leave to provide any brief and focused Reply submissions they wish within 2 weeks of receipt of the Plaintiffs' Supplementary Submissions. Similarly, I decline to impose any strict page limit on those Reply Submissions but would also expect that they also will be similarly succinct and on point.
