- 4) Before I reached the stairs I came upon Jason Lavigne, whom I know in person, and Ezra Levan: whom I recognized from Rebel News, both of whom were in what appeared to be in a somewhat heated exchange.
- 5) I followed closely behind both Jason and Ezra on to the main floor as a crowd was gathering, and I overheard another woman mention the name Jeremy Mackenzie and inquire whether Ezra Levant believed Jeremy Mackenzie to be a "Fed".
- 6) In response, Ezra Levant stated that Jeremy Mackenzie was " a Fed and a Neo-Nazi"
- 7) Intrigued by this exchange, I engaged Ezra Levant by asking him how many Feds he knew that had been incarcerated without bail for 68 days.
- 8) Ezra Levant replied by asserting that he knew a significant number of individuals fitting that description
- 9) To further clarify his claim, I then asked Ezra Levant to provide the name of one such individua-
- 2) However, Ezra Levant chose to disregard my inquiry and departed from the conversation without providing a response.
- 11) I make this affidavit in support of Jeremy MacKenzie's claim for defamation and assert that the events and statements described herein are truthful and accurate to the best of my knowledge and belie:
