- 1. The plaintiff Jeremy MacKenzie claims against all defendants jointly and severally:
  - a. General, aggravated, or exemplary damages in the amount of \$35,000.00;
  - b. Pre- and post-judgment interest pursuant to the *Courts of Justice Act*, RSO 1990, c C.43, as amended;
  - c. Costs of this action in the maximum amount permitted under Rule 19 of the *Rules of the Small Claims Court,* O Reg 258/98; and
  - d. Such further and other relief as this Honourable Court deems just.

## Background

- The plaintiff Jeremy MacKenzie ("Mr MacKenzie") is an individual residing in Nova Scotia. Mr MacKenzie publishes podcasts on various social media platforms.
- 3. The defendant Rebel News Holdings Inc is a company organized under the laws of Ontario with a registered office in Toronto, Ontario. The defendant Rebel News Network Ltd is a company organized under laws of Canada with a registered office in Toronto, Ontario. Collectively ("Rebel News"), these two defendants own and operate a news-opinion website, a YouTube video commentary channel, and several audio podcast series.
- 4. Ezra Levant ("Mr Levant") is an individual who is principal to the Rebel News entities. Mr Levant hosts a podcast series called *The Ezra Levant Show*, advertised as broadcasting his "contrarian and conservative take on free speech, politics, and foreign policy through in-depth commentary and interviews".

5. At all material times, Mr Levant was acting both on his own personal behalf and in his capacity as principal to Rebel News.

#### The Ezra Levant Show broadcast on July 25, 2023

- 6. On July 25, 2023, the defendants broadcast an episode of *The Ezra Levant Show* entitled "I'm in Lethbridge as justice hangs in the balance for the Coutts 4 truckers" (the "July 25 Podcast"). Mr Levant, in the July 25 Podcast, discusses Mr MacKenzie's purported influence over the criminal proceedings against the four accused in the Coutts protest incident (the "Coutts Four"). Several remarks therein were false and defamatory.
- 7. The July 25 Podcast broadcasts that Mr MacKenzie "has set up an explicitly racist organization" called Diagolon. The podcast says the Coutts Four were then enabled to "LARP [...] pretending to be in the Diagolon. [...] Suddenly, they're transformed from being 'oh, that's just a country boy and his rifle and bullets' to 'oh, there's a Diagolon patch there [so] this is part of some uprising [or] revolutionary war'."
- 8. It states that government controlled or influenced events. "Isn't it odd that the leader of Diagolon isn't in jail for 500 days, but these pawns on the chess board are in jail for 500 days. I tell you, sure looks like a fed[eral agent] to me. [...] Certainly not absurd. A generation ago, you might recall that CSIS actually created a hate group called the Heritage Front. [...] The man who actually led Canada's most notorious hate group was working for the government the whole time. [...] Jeremy MacKenzie is the reason that these charges were laid and that these men are in prison. Any he may be the reason that they are convicted. He gave the prosecution what they were missing."

### The July 25 Podcast is defamatory

- 9. The July 25 Podcast states plainly or implies by innuendo:
  - a. That Mr MacKenzie founded an explicitly racist organization;
  - b. That Mr MacKenzie is a government agent;
  - c. That Mr MacKenzie concocted a social movement to entrap the Coutts Four in a criminal offence.
- 10. In reality, the July 25 Podcast is false in those respects and stretches beyond fair comment. Mr MacKenzie has not espoused explicit racism, has not founded any organization, and has not acted for government after his military service. His public commentary is no more "explicitly racist" than Mr Levant's. Mr MacKenzie is, in no way, a party to any scheme devised to entrap militants in criminal offences. Diagolon is no more an organization than the Rebel News audience.
- 11. The July 25 Podcast has harmed Mr MacKenzie's reputation. He is known to be strictly opposed to government overreach. He is simply a social media personality to whom others have ascribed more significance than he ever intended. He does not conspire with government to concoct grounds for criminal prosecution. He relies on his reputation to make a living.
- 12. As the July 25 Podcast remains available to the public for download, the July 25 Podcast is a continuing act.

13. The July 25 Podcast tends to lower Mr MacKenzie in the estimation of reasonable people and, in particular, would cause her to be regarded with hatred, contempt, ridicule, fear, or dislike.

# Notice under the *Libel and Slander Act*, s 5(1)

- 14. Mr MacKenzie gave notice to the defendants in the meaning of the *Libel and Slander Act*, RSO 1990, c L.12, s 5(1), on or about August 22, 2023. Attached hereto as Schedule "B" is that notice.
- 15. Mr Levant and Rebel News acknowledged Mr MacKenzie's notice, but refused to retract their defamatory remarks. Attached hereto as **Schedule "C"** is their responding correspondence.

I am litigation counsel to Jeremy MacKenzie and am corresponding in respect of the above-captioned podcast episode (the "**July 25 Podcast**"). This notice is duly delivered to Rebel News Network Ltd, Rebel News Holdings Inc, and yourself personally, pursuant to the *Libel and Slander Act*, RSO 1990, c L.12 (the "*Act*"), s 5(1). The July 25 Podcast discusses Mr MacKenzie's purported influence over the criminal proceedings against the four accused in the Coutts incident (the "**Coutts Four**"). Several remarks therein were false and defamatory.

The July 25 Podcast broadcasts that Mr MacKenzie "has set up an explicitly racist organization" called Diagolon. The podcast says the Coutts Four were then enabled to "LARP [...] pretending to be in the Diagolon. [...] Suddenly, they're transformed from being 'oh, that's just a country boy and his rifle and bullets' to 'oh, there's a Diagolon patch there [so] this is part of some uprising [or] revolutionary war."

It states that government controlled or influenced events. "Isn't it odd that the leader of Diagolon isn't in jail for 500 days, but these pawns on the chess board are in jail for 500 days. Diagolon is no more an organization than Trekkies are. Star Trek producers do not "lead" Trekkies any more than Mr MacKenzie "leads" Diagolon. Mr MacKenzie ran a regular podcast. Diagolon is its fanbase.

The July 25 Podcast has harmed Mr MacKenzie's reputation. He is known to be strictly opposed to government overreach. He is simply a social media personality to whom others have ascribed more significance than he ever intended. He does not conspire with government to concoct grounds for criminal prosecution. He relies on his reputation to make a living.

We request and require that you retract the statements summarized above, as well as apologize, in a subsequent *The Ezra Levant Show* podcast episode before September 1, 2023. Failing which, Mr MacKenzie intends to bring an action for defamation. While this correspondence should be considered a Notice of Action pursuant to the *Act*, s 5(1), Mr MacKenzie does not waive the position that the July 25 Podcast is not a "broadcast" under the *Act*. The July 25 Podcast remains publicly available for streaming and, therefore, is a continuing act.

## Re: Rebel News and Jeremy MacKenzie

We act for Rebel News and its principal, Ezra Levant.

Your letter to our client dated August 21, 2023 has been brought to our attention and we have instructions to provide the following response.

Mr. Levant acknowledges having made statements concerning your client in his July 25 podcast. He stands by them unequivocally.

Mr. Levant's statements concerning the connection between your client and Diagolon were based on facts previously reported in the media, including mainstream media, on many occasions. Your client has been described repeatedly as Diagolon's founder and *de facto* leader.

The other statements made by Mr. Levant concerning your client were clearly opinions, which Mr. Levant was entirely entitled to express. These opinions were fairly reached given your client's history of public expressions, for example:

(a) criticizing the Nuremberg Trials as having been unfair;



- (b) speaking sympathetically of one of the Nazi leaders who stood as a defendant at that time;
- (c) referring to Rebel News as "Jewish supremacist media"; and
- (d) musing about raping the wife of Conservative Party leader Pierre Poilievre.

Your client also has a history of boasting about having reported possible criminals to the RCMP, thereby acting as an unofficial government agent.

Mr. Levant was entirely justified in advancing the opinion that your client and Diagolon provided a connection among the Coutts defendants that made it easier for the police to charge them with criminal offences.

It follows that our client has absolutely no intention whatever of issuing a retraction and apology as demanded in your letter. If your client wishes to pursue the matter by means of a defamation action, as you have threatened, we will accept service of process.
