

3. AND FURTHER that they at the same time and place aforesaid, without lawful excuse and with intent to harass Dr. Robert STRANG, repeatedly communicate, or cause repeated communications to be made, with them by means of telecommunication, contrary to Section 372(3) of the Criminal Code. ⁸⁵⁵⁵⁰⁹¹⁵
4. AND FURTHER, that they at the same time and place aforesaid, did engage in any conduct with the intent to provoke a state of fear in Dr. Robert STRANG, a health professional in order to impede them in the performance of their duties, contrary to Section 423.2(1)(b) of the Criminal Code.
