Count 1

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did possess
a prohibited firearm, an Armi Jager AP80 semi-automatic rifle, without being the holder of a licence under which he may possess
the firearm, or without being the holder of a registration certificate for the firearm, contrary to Section 91(1) of the Criminal Code.

Count 2

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did possess
a prohibited firearm, a CZ CZ858 Tactical-2 semi-automatic rifle, without being the holder of a licence under which he may
possess the firearm, or without being the holder of a registration certificate for the firearm, contrary to Section 91(1) of the Criminal
Code.

Count 3

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did possess
prohibited devices, 5 black handgun magazines capable of containing 15 cartridges, while not being the holder of a licence under
which he may possess it, contrary to Section 91(2) of the Criminal Code.

Count 4

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did possess
prohibited devices, 4 CZ magazines capable of containing 30 cartridges, while not being the holder of a licence under which he
may possess it, contrary to Section 91(2) of the Criminal Code.

Count 5

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did possess
a prohibited device, a CZ detachable magazine capable of containing 30 cartridges, while not being the holder of a licence under
which he may possess it, contrary to Section 91(2) of the Criminal Code.

Count 6

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did without
lawful excuse use, carry, handle, ship, transport or store a firearm, prohibited weapon, prohibited device, or ammunition, a Rossi
Ranch Hand rifle, in a careless manner or without reasonable precautions for the safety of other persons, contrary to Section 86(1)
of the Criminal Code.

Count 7

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did without
lawful excuse use, carry, handle, ship, transport or store a firearm, prohibited weapon, prohibited device, or ammunition, a K100
Dynamic handgun, in a careless manner or without reasonable precautions for the safety of other persons, contrary to Section
86(1) of the Criminal Code.

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did without lawful excuse use, carry, handle, ship, transport or store a firearm, prohibited weapon, prohibited device, or ammunition, a CZ VZ58 Sportster semi-automatic rifle, in a careless manner or without reasonable precautions for the safety of other persons, contrary to Section 86(1) of the *Criminal Code*.

Count 9

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did without lawful excuse use, carry, handle, ship, transport or store a firearm, prohibited weapon, prohibited device, or ammunition, a Mossberg shotgun, in a careless manner or without reasonable precautions for the safety of other persons, contrary to Section 86(1) of the *Criminal Code*.

Count 10

Landon PREIK, on or about the 2nd day of November, 2021, at or near Chilliwack, in the Province of British Columbia, did without lawful excuse use, carry, handle, ship, transport or store a firearm, prohibited weapon, prohibited device, or ammunition, a CZ 75 Luger semi-automatic handgun, in a careless manner or without reasonable precautions for the safety of other persons, contrary to Section 86(1) of the *Criminal Code*.
