Conditions Attachment/ Annexe des conditions

Condition 1: You must not possess, directly or indirectly any weapon as defined by the Criminal Code, including: (a) firearms, and ammunition; (b) cross-bows, prohibited or restricted weapons or devices, or explosive substances; (c) anything used, designed to be used or intended for use in causing death or injury to any person, or to threaten or intimidate any person; (d) any imitation firearms or weapons, including any compressed air guns or bb/pellet guns; or (e) any related authorizations, licences and registration certificates, and you must not apply for any of these.

Condition 2: You must not be in any residence where any other person keeps or stores any firearm, crossbow, prohibited weapon, restricted weapon, prohibited device, ammunition or explosive substance.

Condition 3: You must not post anything to social media, including Facebook, Instagram and YouTube.
