

CANImmunize is a website and mobile app that gives people the power to safely store and manage their immunization records. We refer to both the website and mobile app together as "CANImmunize". For more information visit: www.canimmunize.ca.

Users that create a CANImmunize account will be subject to our Privacy Policy and Terms of Use. Users must read and agree to the Privacy Policy and Terms of Use prior to using CANImmunize, and review them with individuals for whom they manage immunization records for the platform.

CANImmunize is committed to the protection of personal information. For the purposes of this Privacy Policy, personal information means information that could be used to identify an individual, such as a name, date of birth or postal code. Personal information also includes information relating to the medical care or health of an individual. This Privacy Policy sets out the





What is CANImmunize?

CANImmunize was originally developed by researchers at The Ottawa Hospital. On January 6th, 2020, CANImmunize became a company, CANImmunize Inc.



You can use CANImmunize to...

- Back up your immunization records
- Synchronize your records between your devices
- Send your information to integration partners, such as local health authorities
- Receive reminders of when vaccinations may be recommended, updates on available vaccinations, or notices of vaccine-preventable outbreaks in your area
- Access expert-reviewed information about immunization
- Learn about vaccination and other healthy behaviours
- Track other health information you choose to enter along with your immunization information

You can do these things for yourself, for your children or dependents, or other individuals who give you permission to do so.

To create an account, you must input your name, email address, a password, and the first three digits of your postal code or the country you live in. You may then create records within your account to track the vaccinations of yourself, your children, other dependents, or other individuals who have given you permission to do so.

When you set up records for yourself and/or others you may have the option to activate tools that will allow you to share immunization information with integration

partners for yourself or others at any time using the settings within each record in your account.

Providing consent for yourself and others

When you create a record for another person, you will need to indicate that they have given their consent for you to store and manage their immunization information on their behalf, including the options chosen.

Before creating a record for a minor who has obtained mental capacity to consent as defined by applicable law, you will need to explain these policies to them in order to help them understand that they may choose whether to give or not give their consent.

If you continue to manage the immunization information of a minor once they have obtained mental capacity to consent as defined by applicable law, you must indicate that you have received their consent to do so. Please note that when the minor reaches age 16, CANImmunize will ask you to confirm that you have obtained new consent from them to manage their information.

If an individual whose record is being managed by an account holder wants to withdraw consent for that person to manage their record and the account holder does not comply, the individual should contact the CANImmunize privacy office at privacy@canimmunize.ca.

The information you input into the app is owned by you. Other than as stated here, CANImmunize will never share your personal information with any third party without your consent, unless it is required to do so by law.

How we protect your personal information

When you enter information into your account, the information is sent through a secure encrypted (coded to prevent access by others) connection to the CANImmunize servers where it is also encrypted and stored. The servers and files are in data centres located in Canada which are provided by Amazon Web Services (https://aws.amazon.com/privacy/).

CANImmunize follows the highest industry standard practices for sending, storing, and encrypting personal health information (ISO/IEC 27001 - Information security management system (ISMS) and NIST Cybersecurity Framework). CANImmunize applies strong security measures to protect your information by stopping others from accessing, altering, disclosing or destroying it. These security measures include administrative, technical, and physical safeguards to protect your data against loss, theft, or misuse.

How can you protect your data?

If you use one of the CANImmunize mobile apps, a copy of all of your account data is also stored on your device so that you can access it offline. This data is encrypted, and will remain on your device until you delete your account.

Device Manager) that lets you remotely wipe your device if you lose it. You should never share your password with anyone.

Does CANImmunize collect any data about my use of the website and mobile app?

CANImmunize automatically collects data about the devices and connections you use to connect to the website and mobile app. Here are some examples of the types of data we collect:

- Your device's operating system, hardware and software versions, settings, and identifiers
- Your browser type, language, time zone, and the IP address you use to connect

As with most websites, CANImmunize also automatically collects data about how you use the website and mobile app.

CANImmunize collects this data to provide you with user and technical support, to manage the platform and improve the services we provide, to understand how users are connecting to CANImmunize, and to detect, investigate or prevent violations of our Terms of Use.

CANImmunize protects this data in the same secure manner as it protects your personal information.

Like many other websites, CANImmunize uses "cookies" to collect and store data on your computer or device to help improve your experience using the CANImmunize Platform. Please see the Cookie Policy below for more details.

You may also allow CANImmunize to use your device's location services. This location information is used to provide you with updates about local vaccine preventable disease outbreaks. This location information is not sent to or stored by CANImmunize and is only used for this purpose. You can control CANImmunize's access to your devices' GPS at any time from your device Location Services settings.

How will CANImmunize use my information?

CANImmunize will use your information to send you communications about vaccinations and other healthy behaviours, including information from integration partners such as local health authorities, updates about outbreaks near you if you choose to use location services, and periodic updates about CANImmunize Inc and its platforms. You will be offered the ability to opt out or unsubscribe from these communications. If you have consented to sharing your information with one or more integration partners, CANImmunize will share it with them.

furthers the purposes for which you consented to provide the personal information. These transferees will be required to maintain privacy and data security standards similar to our own. This sort of transfer is considered a use not a disclosure under Federal privacy legislation. By creating an account and storing your immunization information in the app, you are also consenting to allow CANImmunize to use it in de-identified and/or aggregate form for research purposes in the health sector. De-identified information is information about you, but it has been stripped of identifiers such as your name or date of birth and cannot be associated with you as an identifiable individual. Aggregate information is data combined from several measurements; when data is aggregated, groups of observations are replaced with summary statistics such that the data cannot be linked back to an identifiable individual. This will happen only where the research has been approved by, and is protected by, the policies of a Research Ethics Board.

CANImmunize will also use aggregate information to inform its understanding of trends in vaccination, opportunities to improve immunization rates or to generate other insights and may share this aggregate information with third parties.

Before CANImmunize uses or discloses your personal information for any other purpose, we will always ask for your consent.

The information you enter into CANImmunize is your personal information. You may update it or remove it if you no longer wish to use CANImmunize. You can erase your personal information from CANImmunize by deleting your account. This functionality is available in the Account Settings menu. Once you delete your account, CANImmunize cannot get your information back. Once information becomes deidentified and once in aggregate form, it cannot be deleted. When you delete your account, your personal information will be removed from the active user databases, but it may stay in backup storage for up to 30 days before it is completely removed or destroyed.

If you have given consent for CANImmunize to share your information with an integration partner, this partner will have a copy of your information. This information is not under CANImmunize's control. When you delete your CANImmunize account, any of your information held by this integration partner will not be deleted from their records. If you need to delete any information that has been shared with an integration partner, you will need to contact them directly.

How can I contact CANImmunize if I have questions?

CANImmunize has a privacy officer whose job is to make sure the highest standards of privacy and security are upheld. The privacy officer also answers questions, concerns, and complaints about users' privacy. You can



Cookies Policy

Like many other websites, CANImmunize uses "cookies" to collect and store data on your computer or device to help improve your experience using the website and/or mobile app.A cookie is a text file that is placed in your web browser's memory. Cookies used by CANImmunize will not be used to run programs or to deliver malware or viruses to your computer or device.

One of the cookies CANImmunize installs is used to track your session on the website, so that you can remain logged in until your session ends.

Most web browsers (including Firefox, Google Chrome, Internet Explorer, Edge, Safari and Opera) are set up to accept cookies, unless you choose to disable this feature. If you choose to refuse cookies, you will not be able to access your CANImmunize account from www.canimmunize.ca.

CANImmunize may also install cookies that are used by third-party services, like Google Analytics, or Facebook, which help CANImmunize to better understand the Platform's userbase and target advertisements to acquire new users of the platform. Use of these services provides CANImmunize with aggregate, non-identifying data describing our users. It does not make any of your personal information stored on any other platform accessible to CANImmunize, nor does it provide any of your CANImmunize personal information to any other platform.

need for users to get a minor's consent when they have obtained mental capacity to consent as defined by applicable law, rather than just at age 16.

- We added a note that you should never share your password with anyone.
- We clarified examples of the content of communications about vaccinations and other healthy behaviours that you consented to receive, which can include updates about outbreaks near you if you have chosen to use location services, as well as periodic updates about CANImmunize and its platforms. You can always opt out of notifications in the same way as before.
- We added that we may process your personal information, excluding health information, using third parties such as IT services, to further the purposes for which you consented to provide it, and that these companies will be required to maintain privacy and data security standards similar to our own.
- We clarified that we may use aggregate information (non-identifiable group statistics) to generate other insights in addition to the alreadystated uses of informing our understanding of trends in vaccination and opportunities to improve immunization rates.
- We clarified the Terms of Use Security section to reflect that while we use strong and reasonable measures to protect security, we cannot guarantee protection of data from loss, theft or disclosure.
