The request is premised on the size of the Plaintiff's responding motion record coupled with the late delivery of that record. Having reviewed the motion record, I agree that it would be unfair to require the Attorney General to proceed on a large record that was not delivered in a timely manner. Accordingly, the hearing scheduled for August 20, 2024, is adjourned. The parties shall confer and advise the Court Registry of their mutually available dates for a hearing in September and October. In the interim, no further steps will be taken in the proceeding until the motion has been determined. The Attorney General seeks costs of the adjournment.
