2. That, immediately after execution of paragraph 1 of this writ, you pay Her Majesty, in pursuance of the said Certificate, the amount levied in respect of the sum or sums payable thereunder to Her Majesty and of interest on such sum or sums.

3. That, immediately after execution of paragraph 1 of this writ, you pay any part of the amount levied in respect of fees and expenses of execution that you are not entitled by law to retain to the person who is entitled by law thereto or, in case of any doubt with regard to all or any part of such amount, that you pay such amount or such part thereof, into court.

4. That you endorse on this writ immediately after execution thereof a statement of the manner in which you have executed it and send a copy of the statement to Her Majesty, and that, if you pay any money into court pursuant to this writ, you file a copy of the aforesaid statement concurrently with the payment into court.

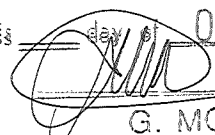

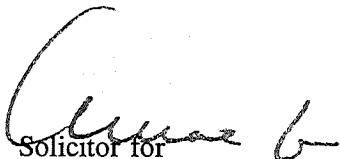
