Canadian military spent more than \$1 million on controversial propaganda training linked to Cambridge Analytica parent firm (Ottawa Citizen)

The Canadian Forces spent more than \$1 million on behaviour modification training used by the parent firm of Cambridge Analytica, the company that was the centre of a scandal in which personal data of Facebook users was provided to U.S. President Donald Trump's political campaign. The two contracts to train military and civilian public affairs staff at National Defence headquarters in Ottawa were revealed Monday in a report by Emma Briant, a professor at Bard College in the U.S. and a specialist in researching military propaganda...Briant noted the training the Canadian military staff received is a direct descendent of SCL Group's "behavioural dynamics methodology" which promises to help military clients analyze and profile groups to find the best strategy to effectively influence a target audience's behaviour...A spokesperson for the Department of National Defence said the intent of the training contracts was to have military public affairs staff "better identify and understand key audiences" so they could create communications campaigns that "are more customized and beneficial." Staff were also taught strategic campaign planning and "audience research," he added.

Ukrainian officers hold exercises on British destroyer (Ukrinform)

Ukraine's Special Operations Forces officers and their colleagues from NATO member states have held joint exercises on UK Royal Navy's destroyer Dragon. "Reconnaissance officers of the 73d special purpose naval centre of the Special Operations Forces of the Armed Forces of Ukraine held joint exercises with colleagues from NATO member states on UK Royal Navy's destroyer Dragon," the press service of the Ministry of Defence of Ukraine informs. During the exercises, boarding operations on the destroyer, close-in fighting, and clean-up operations were practised. Joint exercises are held as part of Operation Orbital, the UK's training mission to Ukraine.

African Union lifts Mali's suspension imposed in the wake of coup (Al-Jazeera)

The African Union on Friday lifted its suspension of Mali which went into effect after a military coup toppled the West African nation's government in August. The decision comes three days after the West African regional bloc ECOWAS announced it was ending its tough post-coup sanctions on Mali, saying it wished to back the country's return to civilian rule. In a communique, the regional heads of state cited "significant advances" toward a return to democracy in Mali, noting the selection of a civilian president and prime minister to head the process. The sanctions included border closures and a ban on commercial trade and financial flows but not basic necessities, drugs, equipment to fight coronavirus, fuel or electricity.

Gunmen Kill Five Villagers In Central Mali (AFP)

At least five Malian villagers have been killed by suspected jihadists in the centre of the country where attacks and ethnic clashes have been on the rise, witnesses and local officials said on Sunday. The attack followed the kidnapping by gunmen on Tuesday of around 20 people at a weekly market in the same village, Farabougou, near the central Malian town of Niono. "The village is cut off from the country by terrorists who have blocked all access routes," said village chief Boukary Coulibaly. Villagers trying to enter the area were ambushed, leaving five dead and fifteen wounded, he said. Another local official said six people had been killed. A resident contacted by AFP by phone also said that six civilians were killed by the jihadists, and others were missing.

Nigeria abolishes special police squad after nationwide protests (Washington Post)

The police officers accused him of speeding, but Dare Olaitan felt that wasn't true. The 29-year-old filmmaker in Nigeria's biggest city, Lagos, says he requested proof. "Then they slapped me, yanked away my phone and keys and said, 'We are going to an ATM,' " Olaitan said. The men, who'd pulled him over in an unmarked van, identified themselves as part of the federal Special Anti-Robbery Squad, or SARS, a Nigerian police unit that has been tasked over the past three decades with fighting violent crime, including banditry and kidnapping. Similar tales blazed across social media in recent days as thousands of protesters filled the streets in several Nigerian cities to urge the leaders of Africa's most populous nation to disband the squad. They said it routinely commits the kind of crimes it is supposed to thwart.

Swiss Hostage Killed In Mali Was Missionary: Govt (AFP)

A Swiss woman thought to have been killed in Mali was a missionary abducted in 2016, the Swiss foreign ministry said Saturday. Beatrice Stoeckli was a missionary from Basel who was working in Timbuktu when she was taken four years ago — having already been abducted by jihadidsts once before, in 2012, Swiss news agency Keystone-ATS reported. The Swiss authorities said in a statement released late Friday that for the past four years they had been working with the Malian authorities and other partners for her release.

Report says high ranking jihadists released in Mali exchange (BBC)

More information has come through, following the release of four hostages in Mali last week. They included Malian opposition leader Soumaila Cisse, French humanitarian Sophie Petronin, and two other Italian hostages. It seems they were released in exchange for jihadists or suspected jihadists and more than 200 prisoners in Malian prisons, including two key leaders of the al-Qaeda in Islamic Maghreb (AQIM), who played a key role in terror attacks in Mali as well as in Cote d'Ivoire and Burkina Faso.

Factbox: Foreign hostages held in West Africa's Sahel region (Reuters)

Four hostages including a prominent Malian politician, two Italians and French aid worker Sophie Petronin, have been released in Mali after negotiations led by the West African nation's security services and international partners. Following are details of the at least six foreign hostages still held by Islamist insurgents in Mali, Burkina Faso and Niger.

<u>Victims or villains? The volunteer fighters on Burkina Faso's front line</u> (The New Humanitarian)

When Burkina Faso's government called for civilians to fight against the jihadists terrorising their communities, Amadoum Tamboura was stirred to act. But the weapons the politicians promised never arrived, leaving the 56-year-old defenceless as militants attacked his village. "We were told our mission was to protect our community. [But] you can't use your bare hands," said Tamboura, who fled along with hundreds of others and now lives in the northern town of Kongoussi...But nine months into the programme, volunteers who were supposed to receive weapons and two weeks of training from the government told The New Humanitarian they were ill-equipped and often too afraid to fight the better-armed and battle-hardened militants.

Iran-backed militias offer truce for U.S. troop withdrawal (AP)

Iraqi militias backed by Iran have agreed to temporarily halt attacks targeting the American presence in Iraq on the condition that U.S.-led coalition troops withdraw from the country in line with a parliamentary resolution, three of the militia officials said Sunday. The militia officials spoke to The Associated Press just hours after a roadside bomb targeted a convoy transporting equipment for the U.S.-led coalition on a highway south of Baghdad, damaging one vehicle, an Iraqi army statement said. The attack prompted questions over whether such a truce could hold across all militia factions. Roadside bombs and especially rocket attacks targeting the U.S. Embassy -- located inside the heavily fortified Green Zone in Baghdad -- have become a frequent occurrence and have strained ties between Baghdad and Washington.

Al-Qaeda And Islamic State: A 'Fratricidal' Clash (AFP)

To the uninitiated, Al-Qaeda and the Islamic State (IS) group may be pursuing the same long-term goal of spreading Islamic law through territorial expansion and deadly violence. But actually, their ideology and methods differ so fundamentally that they are increasingly turning on each other. Last month, IS in West Africa (ISWAP) released a video showing its men butchering fighters presented as members of the JNIM, an al-Qaeda franchise, in Mali. Fifty-two were killed. According to Mohammed Hafez, a professor at the Naval Postgraduate School in Monterey, California, internecine fighting has claimed the lives of some 300 jihadists in West Africa's Sahel region since July alone.

NATO Chiefs of Defence elect next Chairman of the Military Committee - Admiral Rob Bauer of the Netherlands Armed Forces (NATO)

Allied Chiefs of Defence today, 9 October 2020, elected Admiral Rob Bauer, Chief of Defence of the Netherlands Armed Forces to be the next Chairman of the NATO Military Committee, the senior military adviser to the Secretary General. Admiral Bauer will take up the position following the end of Air Chief Marshal Sir Stuart Peach's tenure in June 2021.

<u>US Army solidifies requirements to counter small drones</u> (Defense News)

Pentagon leaders approved in late September a set of requirements to help counter small drones, laying a path for how industry can develop technology to plug into a single command-and-control system, according to the general in charge of the effort. The defense secretary delegated the Army in November 2019 to lead the effort to take a petting zoo of counter-small unmanned aircraft systems, or C-sUAS, many of which were rooted in urgent needs from Middle East conflicts, and to consolidate capability into a select group of interim systems. Army Maj. Gen. Sean Gainey, who is leading the effort through the Joint C-sUAS Office, spoke to Defense News on Oct. 2 ahead of the Association of the U.S. Army's annual conference.

The Nagorno-Karabakh conflict is ushering in a new age of warfare (Al-Jazeera)

Both Armenia and Azerbaijan, traditional enemies, have been building up their armed forces over the last decade. They fought a bloody war that ended in 1994, in which tens of thousands of people were killed and hundreds of thousands were displaced on both sides. Azerbaijan's army collapsed and Armenia took control of several regions, including the key regions of Fuzuli and Jabrayil in the south, bordering Iran. President Ilham Aliyev of Azerbaijan has been explicit in his desire to return these regions to Azerbaijan...These tactics have been so effective that many commentators have openly talked about the demise of the tank as an effective instrument of warfare. There is no doubt that tactics will have to change in order for it to survive. Electronic jamming of radar and drone signals — to counter the enemy's sensors, effectively blinding them — and sending in tanks with adequate air defence are two potential changes.

The US military is trialing augmented reality goggles for dogs (CNN)

Dogs working in the United States military could in the future wear augmented reality (AR) goggles that enable soldiers to give them remote commands during operations. The goggles are being developed by Command Sight, a Seattle-based

company, with US Army research funding, and would allow military dogs to assist in rescue operations and scout potentially dangerous areas for hazards and explosives while their handlers remain at a safe distance.

U.S. Africa Policy Needs a Reset (Foreign Affairs)

Early in his administration, U.S. President Donald Trump seemed poised to make major changes to U.S. policy toward Africa. His signature "America first" approach was inherently skeptical of foreign involvement, especially in what he allegedly called "shithole countries" in the developing world. He opposed international trade agreements, including with African nations, that he viewed as unfair to the United States. He sought to reduce U.S. funding for international organizations upon which Africa depends heavily for aid. And as a part of his administration's shift away from countering violent extremism and toward great-power competition with China and Russia, he proposed reducing the small U.S. military presence in Africa.
